Issue 1: Weighting of the Emerging Local Plan Policies.

Paragraph 9.4 of the Committee Report does not identify why the different levels of weight have been applied to each policy.

## Officer response to issue 1:

In accordance with NPPF paragraph 48, the relevant emerging policies in the plan may be given weight in determining applications, according to:

- (a) the stage of preparation of the emerging plan (the more advanced its preparation, the greater weight it may be given);
- (b) the extent to which there are unresolved objections to relevant policies (the less significant the unresolved objections, the greater the weight that may be given);
- (c) the degree of consistency of the relevant policies in the emerging plan to the NPPF (the closer the policies in the emerging plan to the policies in the NPPF, the greater the weight that may be given).

The relevant weighting has been applied accordingly.
