# **REASON FOR SCRUTINY**

It is likely that extreme weather events will become more frequent in future and therefore the borough may suffer more regular, significant flooding events which will have a harmful impact on our communities.

Preventing and responding to flooding is the responsibility of many different agencies. The Council, along with other partners and agencies, can learn from the flooding affect in Leicestershire in January 2024 and help plan for the future to help better protect local people and businesses.

#### WHAT WILL BE INCLUDED

The Panel will consider the roles of Leicestershire County Council as the lead local flood authority, the Environment agency and other agencies as listed above. The Panel will focus on the partnership working between all agencies involved in the Local Resilience Forum and will focus predominately on flood protection.

#### WHAT WILL BE EXCLUDED

Investigating why the floods occurred. The Panel may suggest that the LLFA should investigate in line with their remit and powers.
