### 1. <u>APOLOGIES</u>

Apologies for absence had been received from Honorary Aldermen Bush and Tormey.

### 2. <u>APPOINTMENT OF MAYOR</u>

In accordance with Council Procedure 9.1 of the Council's Constitution, Council considered electing a Mayor for the 2023/24 Council year.



It was proposed by Councillor Hamilton and seconded by Councillor Baines, that Councillor Margaret Smidowicz be elected Mayor of the Borough of Charnwood for the 2023/24 Council year and until her successor becomes entitled to act as Mayor.

In proposing the motion, Councillor Hamilton stated it was a pleasure to nominate Councillor Smidowicz as Mayor of Charnwood for the 2023/24 year. He referred to the way in which many people did not pronounce her name correctly, and stated that it was pronounced ' Smidowits'.

Councillor Hamilton started off by describing how Councillor Smidowicz' family had been evacuated during the war, and that their London home had been destroyed in the Blitz. She was brought up in Buckinghamshire, and Councillor Hamilton described how she had been an independent minded tomboy as a child. He told of how she enjoyed exploring the countryside with her dog, Sally, and climbing trees and haystacks. She was frequently in trouble at school and was no stranger to the cane at her strict Convent school. Despite her rebellious ways as a child, she had always maintained a sense of justice. She had played truant from school one day, but later reported herself to her father.

Councillor Smidowicz started her career working at Midland Bank, but after meeting and marrying Frank Smidowicz, a US Marine, she enjoyed a life at Navy Bases across the world. She had lived in Texas, Cairo, Mississippi and Ghana, but the couple eventually settled in Loughborough.

Councillor Hamilton spoke about Councillor Smidowicz' marriage to Frank, and explained that they had three children and eventually, three grandchildren.

Councillor Smidowicz had resumed her education as a mature student at Loughborough College and this led to a Master's degree in Human Resources and Strategy. She studied the culture of organisations and she believed that the focus should always be on the people. She had an extensive career in academia and had taught many students. She had a strong belief that education can provide opportunities for people to achieve their own goals.

Councillor Hamilton finished by stating that he was certain that Councillor Smidowicz would embrace the role of Mayor with all the focus and energy and sense of duty that she had applied to all the other roles that she had performed. He reiterated that it was a pleasure to nominate Councillor Smidowicz as Mayor.

In seconding the motion, Councillor Baines stated that Councillor Smidowicz had been asked to be the Mayor of Charnwood a number of times and had previously declined, because she felt that she needed to earn the title. She had done a lot of good work in her ward and in her Cabinet appointment, and so she did feel that now was a good time to undertake the role of Mayor.

Councillor Baines highlighted that Councillor Smidowicz' theme for the year was 'cando'. He talked about how hard she had worked in the many roles she had held throughout her political, professional and personal life and stated that she has accomplished much of what she set out to achieve. Councillor Baines referred to



some of her notable achievements. Councillor Smidowicz had spent many hours shaping the Housing of Multiple Occupation Licensing Policy with council officers. She had also secured a £54k grant to support the development of playing fields in Nanpantan, and £30k to hire Conservation Officer to review conservation areas.

Councillor Baines went on to talk about some of Councillor Smidowicz' experiences outside of her council work. He described her as a 'tough egg', and explained that she had been held at gun point in the Egyptian Desert, but refused to hand over any belongings. He also spoke about how she nearly died of Cerebral Malaria. Councillor Smidowicz had served her community outside of the council and had spent 18 years as a school governor and had chaired the Academic Board at Ratcliffe College. In addition, she had been a Justice of the Peace for 23 years. Councillor Baines referred to Councillor Smidowicz as a 'clever lady' and highlighted her academic achievements. She had a Bachelors degree, two diplomas and a Master's degree. Her field of study centred around Business Management and Human Resources Management. She had lectured at Loughborough College and Stephenson College, and had introduced the first management course for women at South Nottingham College. Later she set up her own consultancy, doing Open University tutoring and incompany work.

Councillor Baines also referred to Councillor Smidowicz beloved husband, Frank, a US Marine. They had been married for 45 years before Frank sadly died of head and neck cancer. Councillor Smidowicz had chosen a head and neck cancer charity as the focus of her fundraising efforts during her Mayoral year, as well as supporting 'Men and Women in Sheds', the Loughborough-based charity sponsored by Leicestershire and Rutland Age UK.

Councillor Baines finished by stating that he knew Councillor Smidowicz would make an excellent Mayor and he wished her well in her new role.

Following the above speeches, the Mayor put the motion to the vote and it was

**UNANIMOUSLY RESOLVED** that Councillor Margaret Smidowicz be elected Mayor of the Borough of Charnwood for the 2023/24 Council year and until her successor becomes entitled to act as Mayor.

Following this, Councillor Smidowicz signed her declaration of acceptance of office and stated that she felt privileged and humbled that her fellow Councillors had elected her to be the 50th Mayor of Charnwood. She welcomed all Councillors to the meeting, and specifically referred to Councillors that had been newly elected. She thanked the outgoing Mayor and her consort for their dedication during a challenging year. She stated that her family had been a significant support to her and that her consort would be her son-in-law, Timothy Baum. The Mayor also acknowledged the work of Council staff and stated that she was aware of how well staff had responded to recent unexpected national events. She went on to refer to King Charles III's speech and stated that she would emulate his example in highlighting the importance of servitude and collaboration, and recognising that it was people that make things happen.



Following a short adjournment, Councillor Smidowicz (Mayor for 2023/24) officiated for the remainder of the meeting.

### 3. VOTE OF THANKS TO RETIRING MAYOR

Following the election of a new Mayor, Council considered a vote of thanks to the retiring Mayor, Councillor Tillotson.

It was proposed by Councillor Baines and seconded by Councillor Miah that this Council tenders to Councillor Jennifer Tillotson its thanks for the service she has provided as Mayor of the Borough of Charnwood and for the way in which she has presided over the Council's business during the past Council year. The Council records its gratitude for the manner in which she has maintained the position of the Mayoralty and the work she has done in meeting so many people in the Borough throughout the year. The Council also extends its thanks to Mr John Tillotson for his service as Mayor's Consort and for the help and support he has provided to the Mayor and for the considerate and committed way in which he has undertaken his role. The Council assures both Councillor Tillotson and Mr Tillotson that they have the best wishes of all its members for their future health and wellbeing.

In proposing the motion, Councillor Baines stated that Councillor Tillotson's Mayoral year had been a whirlwind and that she had attended 323 events over the year. He said that her hard work as Mayor had left little time for her hobbies, which included sewing, cycling and gardening, as well as participating in the events of the Stage Left Theatre Workshop, of which she was a founding member.

Councillor Baines highlighted that the Mayoral year had not been ordinary. Councillor Tillotson had attended Queen Elizabeth II's Platinum Jubilee events, which included the Lighting of the Beacon in Queen's Park, of which this was one of 1,500 Lighting of the Beacon events running across the nation. Also during her Mayoral year, was the sad news of the death of The Queen. As Mayor, she was called upon to leas the mourning of the people of Charnwood and to recognise Her Majesty's extraordinary service to her people. Councillor Tillotson also read the Proclamation in Queen's Park announcing the beginning of the reign ok King Charles III, with over 1,000 in attendance.

He described Councillor Tillotson as a 'theatre buff' and explained that she had had an extensive background in the arts and leisure sector. She had seen a number of performance at the Town Hall, which she had really enjoyed.

Councillor Tillotson, as Mayor, had attended a number of events at Loughborough University. She had particularly enjoyed the student achievement awards that she had attended twice during her year. She also attended all 18 Graduation Ceremonies for Loughborough University and Loughborough College.

She had the privilege of welcoming the Commonwealth Games Torch Relay to Loughborough and Councillor Baines also spoke of how Councillor Tillotson had attended a charity abseil off the Derby Cathedral, in which he and some friends raised  $\pounds 2,000$  for Rainbow's, which had been the Mayor's charity cause.



Councillor Baines recalled how Councillor Tillotson had been proud of the support that Charnwood had provided to Ukrainian refugees. She had taken time to meet with some of the Ukrainian refugees in Charnwood and learn more about their sacrifices and concerns. She had also attended a vigil to mark one year from the beginning of the conflicts.

In finishing, Councillor Baines thanked Councillor Tillotson, and her Consort, John for all they had done over the past year.

In seconding the motion, Councillor Miah stated that Councillor Tillotson's Mayoral year had been full of events, including the celebrations of The Queen's Platinum Jubilee and attending the Bucking Palace Garden Party in celebration of King Charles III Coronation. He said that he hoped Councillor Tillotson had enjoyed all that her Mayoral year had brought. Councillor Miah had been privileged to attend some events with Councillor Tillotson as Mayor, which he had thoroughly enjoyed. He said he had particularly enjoyed the Mayor's charity dinner and referred to the substantial amount of money raised for Councillor Tillotson's charity, Rainbows.

Councillor Miah referred to the twinning visit that Councillor Tillotson had enjoyed in Belgium, strengthening Charnwood's relationship with European colleagues.

He also referred specifically to the Councillor Tillotson's Consort and husband John. He thanked John and expressed gratitude towards the support that John had provided for Councillor Tillotson over the past year.

In finishing, Councillor Miah stated that Councillor Tillotson had had a Mayoral year steeped in historic events and thanked her for her services as the Mayor of Charnwood.

Following the above speeches, the Mayor put the motion to the vote and it was

**UNANIMOUSLY RESOLVED** that this Council tenders to Councillor Jennifer Tillotson its thanks for the service she has provided as Mayor of the Borough of Charnwood and for the way in which she has presided over the Council's business during the past Council year. The Council records its gratitude for the manner in which she has maintained the position of the Mayoralty and the work she has done in meeting so many people in the Borough throughout the year. The Council also extends its thanks to Mr John Tillotson for his service as Mayor's Consort and for the help and support he has provided to the Mayor and for the considerate and committed way in which he has undertaken his role. The Council assures both Councillor Tillotson and Mr John Tillotson that they have the best wishes of all its members for their future health and wellbeing.

Following this, Councillor Tillotson responded by stating that her Mayoral year had gone quickly. She wanted to thank her husband and Consort, John for his support and also other family members, particularly her daughter Lisa, who had also supported her at events.



She thanked everyone that had supported her in raising funds for her Mayoral charity, Rainbows. She referred specifically to Councillor Baines, for his fundraising efforts, and to Morrisons in Loughborough, who fundraised for Rainbows alongside Councillor Tillotson as Mayor. She said the funds that she had raised were more than she ever expected, and amounted to around £6,000.

She went on to thank Councillor Smidowicz, as Deputy Mayor and Reverend Wendy Dalrymple, who had been the Mayor's Chaplain over the past year. Councillor Tillotson also thanked the Council's Civic Officer, Carol Hardy, explaining that Carol had won an award for her work as Civic Officer. She said that Carol's wealth of knowledge was simply irreplaceable.

Councillor Tillotson described some of the highlights of her Mayoral year. These included The Queen's Platinum Jubilee celebrations, afternoon tea at the Great Central Railway and the Lighting of the Beacon at Queen's Park. She had enjoyed events to celebrate the work of local University students, and cutting a ribbon on a new boat for the Peter LeMarchant Trust. She had also attended the Rempstone Steam Fair, riding on a traction engine and the baton relay for the Commonwealth Games. She referred to the Loughborough University Graduation Ceremonies which she had attended and stated that the July temperatures had reached 40 degrees when the air conditioning system had failed.

She spoke about the sad passing of Her Majesty Queen Elizabeth II on 8th September 2023. Operation London Bridge was employed and many events were postponed or cancelled. Instead, she had attended events relating to The Queen's death, most significantly, the Proclamation to announce King Charles III to the people of Charnwood.

Other memorable events had included museum exhibitions, the opening of the Loughborough Fair, children's competitions, Christmas Carol Services and the Winter Solstice on Beacon Hill. After the Christmas period, Councillor Tillotson attended a Burn's Night Supper, Holocaust Memorial events and opened a Sports Pavilion. She witnessed the casting of the Hope Bell, which will be the centre of the memorial to those most affected by the Covid-19 pandemic. She had also enjoyed attending the Buckingham Palace Garden Party with her daughter, Lisa, held to celebrate the recent Coronation of King Charles III.

Councillor Tillotson finished by observing that her Mayoral year had been normal in some respects, following the recovery of the Covid-19 pandemic, but abnormal in other ways. There would never be another year in which a Mayor would celebrate a Platinum Jubilee, mourn the death of the Monarch and subsequently celebrate the Coronation of their successor. She stated that it had been a privilege to be the Mayor of Charnwood.

### 4. <u>APPOINTMENT OF DEPUTY MAYOR</u>

In accordance with Council Procedure 9.1 of the Council's Constitution, Council considered electing a Deputy Mayor for the 2023/24 Council year.



It was proposed by Councillor Bokor, seconded by Councillor Miah and

**UNANIMOUSLY RESOLVED** that Councillor Bradshaw MBE be elected Deputy Mayor of the Borough of Charnwood for the 2023/24 Council year.

Following this, Councillor Bradshaw MBE signed her declaration of acceptance of office and took up her seat next to the Mayor.

#### 5. <u>DISCLOSURES OF PECUNIARY INTERESTS AND OTHER REGISTRABLE AND</u> <u>NON-REGISTRABLE INTERESTS</u>

No declarations were made.

#### 6. <u>MINUTES OF THE PREVIOUS MEETING</u>

The minutes of the meeting of Council held on 27th February 2023 were confirmed and signed.

### 7. <u>APPOINTMENT OF LEADER OF THE COUNCIL</u>

It was proposed by Councillor Hamilton, seconded by Councillor S Forrest that Councillor Jewel Miah be appointed as Leader of the Council for the Council term 2023/24 to 2026/27.

Councillor Miah stated that if he was to be elected as Leader of the Council, he would be happy to discuss the thoughts and ideas of all members of the Council.

It was requested by Councillors Bokor and Baines, and supported by Councillors Snartt, Brookes and D Taylor that a named vote record be taken on this motion.

For the motion – Councillors Ashcroft, Blackshaw, Bottomley, Bradshaw, Cory-Lowsley, Forde, C Forrest, S Forrest, Goode, A Gray, B Gray, Hamilton, Haynes, Infield, Jadeja, Jones, Lawrence, Lennie, Maynard, Miah, Needham, O'Neill, Palmer, Roberts, N Taylor, Tillotson, Woodward and Worrall.

Abstentions – Councillors Campsall and Smidowicz.

**RESOLVED** that Councillor Jewel Miah be appointed as Leader of the Council for the Council term 2023/24 to 2026/27.

### <u>Reason</u>

To make an appointment to the position of Leader of the Council, in accordance with the Local Government Act 2000 and section 9.1 of the Council's Constitution.



Following the resolution, Councillor Miah informed the Council that the councillors appointed to the Cabinet would be Councillors Miah (Leader of the Council), Hamilton (Deputy Leader of the Council and Public and Private Sector Housing), Ashcroft (Finance, Customer and Support Services, Revenues and Benefits), Jadeja (Planning), Jones (Climate Action, Net Zero, Property and Assets), Tillotson (Economic Development, Regeneration and Town Centres), A Gray (Waste, Open Spaces and Leisure Facilities) and Blackshaw (Communities and Neighbourhoods).

Councillor Bokor informed the Council that the Conservative Group had made the following shadow lead member appointments: Councillor Bokor (Leader of the Conservative Group, Loughborough, Economic Regeneration, Corporate Strategy, Green Spaces), Baines (Deputy Leader of the Conservative Group, Finance and Investments), Harper-Davies (Leisure, Waste and Environmental), Seaton (Planning and Renewable Energy) Rattray (Business Support, Climate Action and Tourism), Charles (Regulator and Community Safety Partnership), D Taylor (Housing), Monk (Housing Support), Brookes (Digital Transformation and Customer Service).

Councillor Needham informed the Council that the Green Group had made the following Spokesperson appointments: Councillor Needham (Leader of the Green Group, Housing), Infield (Deputy Leader of the Green Group, Planning), Lawrence (Climate and Environment), Woodward (Communities and Equalities), Forde (Finance).
