<u>Cabinet Report – Public Spaces Protection Order – (Charnwood Borough Council)</u> <u>Dog Control 2023</u>

Summary of Incidents and Enforcement Actions

Numbers of Incidents

- 1. Charnwood Borough Council receive reports of dog fouling to be dealt with in two different ways:
 - First Report of dog foul first report a high number of reports of dog fouling report goes to waste contractor for cleansing
 - Second report within 6 months report goes to waste contractor for cleansing and a patrol is carried out.

The number of dog fouling reports (second reports with a patrol is shown in the table below

2. Dog fouling enforcement is usually by means of a fixed penalty notice (FPN). An authorised Officer must see the owner allowing their dog to foul and not clearing away afterwards for an offence to occur. If the FPN is unpaid the Council can prosecute. The number of fixed penalty notices and prosecutions can be seen in the table below:

3. Charnwood Borough Council also receives reports about issues with dog control. These reports include dog on dog attacks, dogs scaring and worrying people and owners not being on control of their dog. In the last three years the number of dog control reports is as follows:

4. The Council deal with many cases by contacting the individual concerned but the PSPO would offer a location-based order to implement controls in public spaces to prevent dog control issues.

There are also powers within the Anti-social Behaviour Crime and Policing Act 2014 which allows relevant agencies to deal with individuals for dog control issues using Community Protection Warnings and Notices. These powers can be used alongside the PSPO.

> THREE CBC CONDITIONS WITH UNDECLARED CONCLUSIONS ARE INCLUDED IN THE CBC BRIEFING FOR THIS SECOND PSPO CONSULTATION FOR STONEBOW WASHLANDS. ALL THREE ARE EXAMINED IN DETAIL BELOW.

> CONDITION [1] - 'CLEAR EVIDENCE'

> CBC quote: 'It is important to note that an extension of controls will only be considered where there is clear evidence of significant ASB activities, for example dog attacks.'

> CBC WON'T HAVE GATHERED ANY VALID (QUOTE): 'CLEAR EVIDENCE OF SIGNIFICANT ASB ACTIVITIES (I.E. DOG ATTACKS)' ON ANY PART OF STONEBOW WASHLANDS FROM THE OPERATION OF ITS 'DOGS ON LEADS BY DIRECTION' SCHEME. DOGS ON LEADS BY DIRECTION' ALLOWS ALL DOGS TO BE OFF A LEAD UNLESS A SPECIFIC DOG IS DIRECTED TO BE PUT ON A LEAD BY A CBC 'OFFICER' (IDVERDE RANGER). Since its introduction on the entirety of Stonebow Washlands from 6th January 2020, that scheme has, in effect, been PROVEN to be incapable of detecting or enforcing anything AT ALL. Comprehensive proof of that failure, by two independent methods, was provided in my 16th October 2021 report (described earlier).

ONE OBJECTIVE IS TO RE-STATE AND RE-EMPHASISE THE LOOSE DOG ATTACK SITUATION AT STONEBOW, IN AN ATTEMPT TO ACHIEVE CBC RECOGNITION. ANOTHER OBJECTIVE IS TO SATISFY A RECENT WRITTEN CBC REQUEST FOR SPECIFIC EVIDENCE OF SIGNIFICANT ASB (LOOSE DOG ATTACKS) ON THE PLAYING FIELD 'ONLY'. USE OF THE WORD 'ONLY' BY CBC IS APPARENTLY INTENDED TO MEAN INSTANCES OF SIGNIFICANT ASD (JE DOC ATTACKS) DE TABLE OF DEMANDING AND ENDING ON THE DEDA MANDING THE DEVIDE OF AND ENDING ON THE DEVIDED TO MEAN INSTANCES OF SIGNIFICANT ASB (I.E. DOG ATTACKS) BEGINNING, REMAINING AND ENDING ON THE PLAYING FIELD 'ONLY'. I HAVE NEVER PREVIOUSLY THOUGHT IT SENSIBLE TO 'ONLY' REPORT SUCH ARTIFICIALLY CONSTRAINED INFORMATION, BECAUSE IT FAILS TO PROVIDE ALL OF THE AVAILABLE (BUT VERY NECESSARY) EVIDENCE, LEADING TO INCORRECT CONCLUSIONS. NEVERTHELESS, MY FIFTEEN THOUSAND HOURS OR SO OF OBSERVATION AT STONEBOW AND DISHLEY POOL EASILY IDENTIFY SUFFICIENT EXAMPLES OF THAT SPECIFIC TYPE OF INCIDENT, WHICH ARE PROVIDED IN MY COMMENTS BELOW REQUEST NUMBER 5.

CONDITION [2] - 'HISTORICAL DATA AND EVIDENCE'

> CBC quote: 'There will also be an additional resource needed to enforce so historical data and evidence will be reviewed when making any decisions.

Since its introduction on the entirety of Stonebow Washlands from 6th January 2020, that scheme has, in effect, been PROVEN to be incapable of detecting or enforcing anything AT ALL without my assistance. My 16th October 2021 report explains all.

A CLEAR CBC request for input has not been identified. Any future claimed CBC shortage of such information from consultees will be due to that lack of clarity, amongst other possible influences.

> IT IS IMPORTANT TO NOTE THAT MY 16TH OCTOBER 2021 REPORT PROVES THAT CBC'S CLAIM OF 'AN ADDITIONAL RESOURCE NEEDED' IS INCORRECT. IN REALITY, FEWER RESOURCES ARE LIKELY TO BE REQUIRED AND PRODUCTIVITY WILL BE (ALMOST LITERALLY) INFINITELY GREATER, AS IS THOROUGHLY PROVEN IN THAT REPORT AND BRIEFLY EXPLAINED BELOW.

CBC have recently confirmed, in writing, that there is clear evidence of significant ASB dog activities on the ponds area and, subject to the establishment of effective signage and enforcement at Stonebow and Dishley Pool, have correctly imposed 'Dogs on leads at all times' to control it on that area (there being no effective alternative). THE RESOURCES REQUIRED TO OPERATE THAT SCHEME ON THE PONDS AREA ARE, THEREFORE, ALREADY COMMITTED AND WILL REMAIN IN PLACE. It then becomes obvious that the minimum resources solution for the entirety of Stonebow would also be 'Dogs on leads at all times' on the playing field. That simple, easy and efficient measure would combine and thereby reduce signage, policing and enforcement resources required for the ponds area and the playing field in combination, instead of wasting inevitably greater resources in an attempt to operate two entirely different dog control schemes on two imaginarily "different" dog behaviour areas (which are, in reality, nothing of the sort). Not least would be a vast improvement in dog owner compliance, by completely eliminating the presently observed and expressed dog owner confusion caused by illogically different dog control measures on two artificially defined areas that are not separated by any form of barrier, whether dog-proof or not. Signage alone will never be adequately effective and the vast majority of loose dogs will never be adequately controlled until a single, simple, easily understood and coherent dog control measure is applied, clearly signed and efficiently enforced on the entirety of Stonebow Washlands (ponds area plus playing field). 'Dogs on leads at all times' is the only effective solution in all of those respects and far more besides, as I inarguably explain on this survey form and in

my 16th October 2021 report. It is vastly superior, far more productive and considerably more economical than any other dog control scheme yet devised.

> WITH FURTHER REGARD TO RESOURCES, IT IS PROVEN IN MY 16TH OCTOBER 2021 REPORT THAT 'DOGS ON LEADS AT ALL TIMES' IS 100% PRODUCTIVE DURING OFFICER (IDVERDE RANGER) ATTENDANCE, IN STARK CONTRAST TO VIRTUALLY NO PRODUCTIVITY WHATSOEVER AND A COMPLETE WASTE OF CBC RESOURCES BY 'DOGS ON LEADS BY DIRECTION'.

CONDITION [3] - 'A LEGAL TEST'

> NUMBERING IS ARBITRARY.

> LOOSE DOG ATTACK INCIDENT [1] ON THE PLAYING FIELD 'ONLY' - Before being killed by a loose dog in April 2022, the Stonebow cob had already been hospitalised by the RSPCA on two separate occasions due to loose dog attacks. He barely survived the first incident. The second of those incidents was witnessed occurring ON THE PLAYING FIELD (CBC's 'yellow zone') by a visitor who called the RSPCA at the time.

> LOOSE DOG ATTACK INCIDENT [2] ON THE PLAYING FIELD 'ONLY' - I arrived by bicycle at the Stonebow notice board entrance at the same time as a car, which parked on Lindisfarne Drive. A door of the car swung open, a football was ejected down the entrance slope LEADING TO THE PLAYING FIELD and a loose dog leap out and chased after it. I noticed that the swan family, quite well grown, were close by ON THE PLAYING FIELD, so I began moving towards them as I shouted to ask if the dog was "OK with swans" and to advise that the swan family was on the playing field. A man emerged from the car and replied that his dog ignored the swans. A few seconds later, his dog charged into and attacked the swan family ON THE PLAYING FIELD, clearly intent upon causing injury or worse. I dropped my bike, launched into the melee, grabbed the dog's collar and pulled it away from the swan family. The owner eventually caught up, snatched the dog from me and stormed off, grim-faced, towards the ponds area without a word, as if the attack was anybody's fault but his own. I shouted for him to put his dog on a lead, which he ignored. Fortunately, there were no physical injuries to myself, the swan family or the dog. > THE SUPPOSED OPERATION OF 'DOGS ON LEADS BY DIRECTION' ACHIEVED NOTHING.

> LOOSE DOG ATTACK INCIDENT [3] ON THE PLAYING FIELD 'ONLY' - I was leaving Stonebow along the southern path and observed one loose dog pounce upon another loose dog ON THE PLAYING FIELD and attempt rape. The owners separated them and a loud exchange began, which I didn't stay to witness.
 > THE SUPPOSED OPERATION OF 'DOGS ON LEADS BY DIRECTION' ACHIEVED NOTHING.

> LOOSE DOG ATTACK INCIDENT [4] ON THE PLAYING FIELD 'ONLY' – January 2022. The adult swan pair were grazing ON THE PLAYING FIELD when two loose dogs appeared from the Mount Grace Road incline. One of the dogs immediately rushed straight for the cob. The dog was alarmingly aggressive. The dog owner said and did nothing. Fortunately, I was close to the cob, who knew and trusted me, so I was able to quickly stand between the two, albeit at very obvious risk from the aggressive dog. I shouted for the owner to control it, but she continued to ignore the situation, didn't call the dog and merely headed toward the ponds. Thankfully, the dog followed her. She entered the ponds area with both dogs still loose.
 THE SUPPOSED OPERATION OF 'DOGS ON LEADS BY DIRECTION' ACHIEVED NOTHING.

> LOOSE DOG ATTACK INCIDENT [5] ON THE PLAYING FIELD 'ONLY' - March 2022, the swan pen (adult female) was sleeping alone on the playing field. The cob was at the other end of Stonebow, guarding their nest. This was typical behaviour by this pair during the two weeks or so of mating and egg creation prior to incubation. Fortunately, I decided to take some photographs of the pen. A loose dog appeared, charged towards the pen from the small bridge at the north west corner of the playing field and attacked her. I intervened loudly, upon which the dog left the playing field via the same bridge. A dog owner was nowhere to be seen. Thankfully, there were no physical injuries to the pen. Some minutes later, the owner appeared on the path north of the playing field, with his dog still loose. My description of the incident and a request for the dog to be put on a lead was met with foul language and refusal.
 THE SUPPOSED OPERATION OF 'DOGS ON LEADS BY DIRECTION' ACHIEVED NOTHING.

> LOOSE DOG ATTACK INCIDENT [6] ON THE PLAYING FIELD 'ONLY' - In July 2022 a Stonebow visitor, without prompting, raised the subject of an Eastern European man with two very aggressive black dogs. I was already all too well aware of this prticular dog owner, who frequently visits Stonebow (or Dishley Pool) at the same approximate time of day. I formally reported him, his dangerous dogs and his vehicle details and registration to CBC MONTHS AGO, but determining his address is still reportedly ongoing at CBC and no other action has been taken. I still quite frequently see and hear the man shouting loudly at his dogs, usually loose, at Stonebow or Dishley Pool. The visitor said that his innocent dog had been attacked by one of the Eastern European's two dogs. He asked the Eastern European to control his dog, but was ignored. The visitor added that the same dog then attacked a group of flight-

capable swan cygnets ON THE PLAYING FIELD. > *** THE SUPPOSED OPERATION OF 'DOGS ON LEADS BY DIRECTION' HAS THUS FAR ACHIEVED NOTHING, DESPITE MY FORMAL REPORT, INCLUDING VEHICLE DETAILS, PROVIDED MONTHS AGO AND, NOT LEAST, THE CONTINUING, FREQUENT APPEARANCES OF THE OWNER AND HIS DOGS ON STONEBOW OR DISHLEY AT THE SAME APPROXIMATE TIME OF DAY, ALSO REPORTED TO CBC. THIS IS A PRIME EXAMPLE OF A COMPLETE FAILURE OF ONE OF MANY TOTALLY INEFFECTIVE ASPECTS OF 'DOGS ON LEADS BY DIRECTION' (SEE MY 16TH OCTOBER 2021 REPORT FOR COMPREHENSIVE DETAILS).

> LOOSE DOG ATTACK INCIDENTS [7] TO [13] ON THE PLAYING FIELD 'ONLY – At the time of writing, attacks on the playing field by the above-described Eastern European's two loose dogs have been described to me, without prompting, by SEVEN other people/couples. Those dogs are consistently described as extremely aggressive towards people, dogs and/or wildlife, yet 'DOGS ON LEADS BY DIRECTION' HAS FAILED TO ACHIEVE ANYTHING AT ALL DESPITE MY FORMAL REPORT MONTHS AGO. Almost all of the seven were of the firm opinion that the Eastern European's dogs were their prime suspects for the murder of the Stonebow Mute swan cob in April 2022. I've witnessed the man holding one of his loose dogs' collars whilst passing a group of several children playing on the Playing field. He is clearly well aware of the danger his dogs pose, yet he continues to allow them to be loose and, not least, is allowed by the failure of 'Dogs on leads by direction' to have them loose. > THE SUPPOSED OPERATION OF 'DOGS ON LEADS BY DIRECTION' HAS THUS FAR ACHIEVED NOTHING. SEE ABOVE ***

LOOSE DOG ATTACK INCIDENT [14] ON THE PLAYING FIELD 'ONLY' - 14th April 2022. The above-described Eastern European was involved in an exceptionally loud episode with his dogs ON THE PLAYING FIELD. I was on Mount Grace Road, unable to immediately see what was happening, so I rushed down the slope to the playing field to investigate as the Eastern European and his loose dogs went up the slope to Lindisfame Drive and drove off. Two youths had erected tents on the field and were looking extremely stunned and red-faced. A significant incident had

clearly occurred. > THE SUPPOSED OPERATION OF 'DOGS ON LEADS BY DIRECTION' HAS THUS FAR ACHIEVED NOTHING. SEE ABOVE ***.

> LOOSE DOG ATTACK INCIDENT [15] ON THE PLAYING FIELD 'ONLY' - I was walking with my bicycle across the playing field and heard loud shouting behind me. I saw two men with two loose dogs, one medium sized and the other small. The larger dog was speeding towards me. One of the men was shouting loudly at the larger dog, which ran at full speed into my legs. I felt a bite to my leg. The dog stood close, snarling, barking and snapping the air. The men did nothing, apart from continued ineffective shouting. As the men left the playing field to the west, one still shouting, the dog thankfully ran to join them. I checked my leg and could see marks but no bleeding. I checked if there were any vehicles parked at any of the eastern entrances (there were none) and the four weren't seen (or heard) again during this visit or any subsequent visits. > THE SUPPOSED OPERATION OF 'DOGS ON LEADS BY DIRECTION' ACHIEVED NOTHING.

> LOOSE DOG ATTACK INCIDENT [16] ON THE PLAYING FIELD 'ONLY' - I witnessed an attack by a medium-sized dog upon a small one, both loose ON THE PLAYING FIELD. I was close and able to chase the attacking dog away, at risk to myself. The attacking dog's owner was nowhere to be seen. The small dog was left with bleeding nose and ear > THE SUPPOSED OPERATION OF 'DOGS ON LEADS BY DIRECTION' ACHIEVED NOTHING.

> LOOSE DOG ATTACK INCIDENT [17] ON THE PLAYING FIELD 'ONLY' - I witnessed, more than once, a man encouraging his large dog to enter the larger pond, inducing the swan cob to react. He kept the dog on a collar connected to an extremely long length of thick strapping, to allow him to pull the dog, with alarning violence, out of the water by its neck just before the cob reached it. This behaviour by the same man and dog was also witnessed ON THE PLAYING FIELD, once as an encouraged dog attack upon a gathering of Mallard and on another occasion as an encouraged dog attack upon another dog, which led to a fight between the two owners. He hasn't been seen at Stonebow since, although that does not necessarily mean that he no longer visits. > THE SUPPOSED OPERATION OF 'DOGS ON LEADS BY DIRECTION' ACHIEVED NOTHING.

> Other dog owners using extremely long, makeshift leads are also seen at Stonebow (and Dishley Pool). One Stonebow dog owner I spoke to, who was using a very long length of rope, said, with a grin and a nod at his dog, that '...he likes to nip other dogs'. UNBELIEVABLY, HE WAS UNASHAMEDLY ADMITTING THAT THE ROPE WAS LONG IN ORDER TO DELIBERATELY ALLOW HIS DOG THE FREEDOM TO BITE OTHER DOGS!

> EVIDENCE OF SIGNIFICANT ASB (I.E. LOOSE DOG ATTACKS) ON THE STONEBOW WASHLANDS PONDS AREA (CBC'S 'BLUE ZONE') CAUSED BY LOOSE DOGS COMING OFF THE PLAYING FIELD (CBC'S 'YELLOW ZONE').

Of considerable relevance, the following will provide some examples (amongst many witnessed) of previously submitted written evidence to CBC of significant ASB (i.e. loose dog attacks) on the ponds area (CBC's 'blue zone') due to loose dogs COMING OFF the playing field (CBC's 'yellow zone') onto the almost immediately adjacent southern bank of the smaller pond in the ponds area. Note that there is no physical barrier, let alone a dog-proof barrier, between the playing field and the ponds area.

> FOR SOME UNIDENTIFIED REASON, THE FOLLOWING EVIDENCE HAS RECENTLY BEEN OVERLOOKED BY CBC. THEY HAVE INSTEAD DECLARED 'NO EVIDENCE' OF SIGNIFICANT ASB (I.E. LOOSE DOG ATTACKS)' ON THE PLAYING FIELD 'ONLY'. USE OF THE WORD 'ONLY' BY CBC WAS EXPLAINED EARLIER. BECAUSE OF THAT SERIOUS OVERSIGHT, THE UNREALISTICALLY LIMITING 'ONLY' STIPULATION AND A FAILURE TO RECOGNISE THE TOTAL INEFFECTIVENESS OF 'DOGS ON LEADS BY DIRECTION', CBC RECENTLY CHOSE TO CONTINUE WITH THAT SCHEME ON THE PLAYING FIELD.

> CBC HAVE YET TO EXPLAIN HOW THEY EXPECT TO PREVENT DOG ATTACKS ON THE PONDS AREA CAUSED BY DOGS ALLOWED TO BE LOOSE ON THE PLAYING FIELD UNDER THE TOTALLY INEFFECTIVE EVIDENCE ALONE THAT 'DOGS ON LEADS AT ALL TIMES' ON THE PLAYING FIELD IS THE ONLY SENSIBLE SOLUTION.

> THE FOLLOWING LOOSE DOG ATTACKS CAUSED BY LOOSE DOGS COMING OFF THE STONEBOW PLAYING FIELD ONTO THE PONDS AREA ARE TAKEN FROM MY 16TH OCTOBER 2021 REPORT, WHICH DELIBERATELY ENCOMPASSED A RECORDING PERIOD OF NINETEEN MONTHS AT STONEBOW WASHLANDS. 'DOGS ON LEADS BY DIRECTION' WAS IN SUPPOSED "OPERATION" DURING THAT ENTIRE PERIOD. NUMBERING IS AS USED IN MY 16TH OCTOBER 2021 REPORT. SUBSEQUENT ATTACKS WILL ALSO BE DESCRIBED, TO DEMONSTRATE THE INEVITABLE CONTINUANCE OF THE PROBLEM. THE ONLY EFFECTIVE SOLUTION IS TO APPLY 'DOGS ON LEADS AT ALL TIMES' TO THE PLAYING FIELD.

		 In addition to my 16th October 2021 report (see my comments in other sections for details), a short report, entitled
		'Why all dogs must be on leads at all times on the entire Stonebow Washlands site', has been distributed to CBC and elsewhere since April 2022. Regrettably, this survey form is incapable of reproducing essential images. Requests to will secure a complete, illustrated copy of that report. By way of a brief but less informative summary, that report clearly explains how loose dogs on the Stonebow playing field are a danger to children playing, a danger to human cleanliness and health and a SEVERE MORTAL danger to wildlife. In view of its significance and prevalence, the plight of wildlife on that playing field is explained in greater detail immediately below.
		>
		It is far more likely that wildlife (typically Mallard and legally protected Mute swans and their cygnets) will be KILLED by loose dogs on the Stonebow playing field than on the ponds area. CBC or visitor detection of evidence of such deaths is, however, far from likely, given that guilty dog owners or wild predators will remove or consume corpses. Wildlife frequently grazes and grubs on the entirety of that playing field, yet CBC have declared that dogs may be loose on that same field under 'Dogs on leads by direction', despite my 16th October 2021 report proving that scheme to be totally ineffective in every respect. Because wildlife is in clear sight on that open field, it is a very obvious, tempting and extremely easy target for loose ASB dogs inclined to launch attacks (or even some normally well behaved dogs induced to attack and kill by the mere presence of other animals). UNFORTUNATELY AND MOST SIGNIFICANTLY, THERE IS NOWHERE ON THAT FIELD WHERE WILDLIFE MAY QUICKLY ACHIEVE SAFE ESCAPE FROM INJURY OR (MORE LIKELY) DEATH DUE TO LOOSE DOG ATTACKS. UNLIKE THE PONDS AREA, THERE IS NO BODY OF WATER SUFFICIENTLY CLOSE TO OFFER SOME POSSIBILITY OF ESCAPE. The only realistic means of escape from attacking dogs on the playing field is immediate flight. Adult Mallard often react quickly enough and fly out of danger, but adult Mute swans and any flight-capable cygnets are far too heavy to accelerate quickly enough in MOST situations. They can only (and are in any case instinctively inclined to) stand wherever they are attacked by a loose dog and attempt to defend themselves, albeit only by "bluffing" (hissing loudly, spreading their wings wide and raising their plumage to create an illusion of greater strength and size). Swan and cygnet fatalities at Stonebow and Dishley Pool have proven that such defensive "bluffing" is all too often unsuccessful. IN EVEN GREATER DANGER OF INEVITABLE DEATH, HOWEVER, ARE THE VERY YOUNG,
		FLIGHTLESS OFFSPRING OF ANY SPECIES, SUCH AS MALLARD DUCKLINGS AND SWAN CYGNETS, WHICH CANNOT BLUFF, ARE FLIGHTLESS AND ARE INCAPABLE OF ADEQUATE SPEED ON LAND.

> My April 2022 report also describes "blind spots" created by vegetation. Such vegetation prevents wildlife sightings of loose dogs as they approach and attack FROM THE PLAYING FIELD until those dogs are "right on top of" that wildlife, most often and most dangerously on the adjacent southern bank of the smaller pond in the ponds area. A witnessed wildlife death due to that situation was one example amongst five loose dog attack incidents witnessed during a deliberately chosen period of nineteen months for the purposes of my 16th October 2021 report. ASTONISHINGLY, THE TOTAL NUMBER OF INCIDENTS OCCURRING DURING ALL DAYLIGHT HOURS COULD BE THREE TIMES OR SO GREATER THAN THOSE IDENTIFIED BY MY OBSERVATIONS DURING ONE THIRD OF ALL DAYLIGHT HOURS. ALL IS REVEALED IN MY 16TH OCTOBER 2021 REPORT (SEE ABOVE).

> EVIDENCE OF SIGNIFICANT ASB (I.E. LOOSE DOG ATTACKS) ON THE STONEBOW WASHLANDS PLAYING FIELD 'ONLY' (CBC'S 'YELLOW ZONE').

> In the following, 'the ponds area' is CBC's 'blue zone'.' The playing field' is CBC's 'yellow zone', which CBC also call 'the top grassed area'. NOTE THAT THE PLAYING FIELD AND PONDS AREAS ARE DIRECTLY ADJACENT, WITH NO PHYSICAL BARRIER, LET ALONE A DOG-PROOF BARRIER, BETWEEN THE TWO.

> IN AN EMAIL DATED 11TH JULY 2022, CHARNWOOD BOROUGH COUNCIL (CBC) REQUESTED (QUOTE) '...ANY EVIDENCE OF SIGNIFICANT ASB IE DOG ATTACKS FOR THE YELLOW ZONE ONLY.'

> THE WORD 'ONLY' IN THE ABOVE IS APPARENTLY INTENDED BY CBC TO MEAN SIGNIFICANT ASB (I.E. DOG ATTACKS) BEGINNING, REMAINING AND ENDING ON THE PLAYING FIELD 'ONLY'. I HAVE NEVER PREVIOUSLY THOUGHT IT SENSIBLE TO ONLY REPORT SUCH SEVERELY CONSTRAINED INFORMATION, BECAUSE IT FAILS TO PROVIDE ALL OF THE AVAILABLE (AND VERY NECESSARY) EVIDENCE, WHICH COULD LEAD TO INCORRECT CONCLUSIONS. NEVERTHELESS, MY FIFTEEN THOUSAND HOURS OR SO OF OBSERVATION AT STONEBOW AND DISHLEY POOL EASILY IDENTIFY SUFFICIENT EVIDENCE OF THAT SPECIFIC TYPE OF INCIDENT, WHICH IS PROVIDED BELOW.

> I WILL ALSO REPORT SOME EXAMPLES OF INCIDENTS, INCLUDING A 2021 WILDLIFE FATALITY, CAUSED BY UNCONTROLLED LOOSE DOGS COMING OFF THE PLAYING FIELD AND INFLICTING ATTACKS ON THE PONDS AREA. NUMEROUS EXAMPLES OF SUCH HAVE BEEN WITNESSED DURING THE LAST TWELVE YEARS. IT IS INARGUABLE THAT THOSE INCIDENTS WOULD NOT HAVE OCCURRED HAD 'DOGS ON LEADS AT ALL TIMES' BEEN COMPETENTLY APPLIED TO BOTH THE PONDS AREA AND THE PLAYING FIELD. CONTINUING USE OF CBC'S 'DOGS ON LEADS BY DIRECTION' SCHEME ON THE PLAYING FIELD HAS BEEN AND STILL IS THE CAUSE OF LOOSE DOG ATTACKS ON BOTH AREAS, DUE ITS TOTAL INEFFECTIVENESS, AS PROVEN BY TWO INDEPENDENT METHODS IN MY 16TH OCTOBER 2021 REPORT.

> LOOSE DOG ATTACK INCIDENT [1] ON THE PLAYING FIELD 'ONLY' - Before being killed by a loose dog in April 2022, the Stonebow cob had already been hospitalised by the RSPCA on two separate occasions due to loose dog attacks. He barely survived the first incident. The second of those incidents was witnessed occurring ON THE PLAYING FIELD (CBC's 'yellow zone') by a visitor who called the RSPCA at the time.

> LOOSE DOG ATTACK INCIDENT [2] ON THE PLAYING FIELD 'ONLY' – I arrived by bicycle at the Stonebow notice board entrance at the same time as a car, which parked on Lindisfarne Drive. A door of the car swung open, a football was ejected down the entrance slope LEADING TO THE PLAYING FIELD and a loose dog leap out and chased after it. I noticed that the swan family, quite well grown, were close by ON THE PLAYING FIELD, so I began moving towards them as I shouted to ask if the dog was "OK with swans" and to advise that the swan family was on the playing field. A man emerged from the car and replied that his dog ignored the swans. A few seconds later, his dog charged into and attacked the swan family ON THE PLAYING FIELD, clearly intent upon causing injury or worse. I dropped my bike, launched into the melee, grabbed the dog's collar and pulled it away from the swan family. The owner eventually caught up, snatched the dog from me and stormed off, grim-faced, towards the ponds area without a word, as if the attack was anybody's fault but his own. I shouted for him to put his dog on a lead, which he ignored. Fortunately, there were no physical injuries to myself, the swan family or the dog.

> THE SUPPOSED OPERATION OF 'DOGS ON LEADS BY DIRECTION' ACHIEVED NOTHING.

>

> LOOSE DOG ATTACK INCIDENT [3] ON THE PLAYING FIELD 'ONLY' - I was leaving Stonebow along the southern path and observed one loose dog pounce upon another loose dog ON THE PLAYING FIELD and attempt rape. The owners separated them and a loud exchange began, which I didn't stay to witness.
> THE SUPPOSED OPERATION OF 'DOGS ON LEADS BY DIRECTION' ACHIEVED NOTHING. > LOOSE DOG ATTACK INCIDENT [4] ON THE PLAYING FIELD 'ONLY' – January 2022. The adult swan pair were grazing ON THE PLAYING FIELD when two loose dogs appeared from the Mount Grace Road incline. One of the dogs immediately rushed straight for the cob. The dog was alarmingly aggressive. The dog owner said and did nothing. Fortunately, I was close to the cob, who knew and trusted me, so I was able to quickly stand between the two, albeit at very obvious risk from the aggressive dog. I shouted for the owner to control it, but she continued to ignore the situation, didn't call the dog and merely headed toward the ponds. Thankfully, the dog followed her. She entered the ponds area with both dogs still loose.

> THE SUPPOSED OPERATION OF 'DOGS ON LEADS BY DIRECTION' ACHIEVED NOTHING.

> LOOSE DOG ATTACK INCIDENT [5] ON THE PLAYING FIELD 'ONLY' - March 2022, the swan pen (adult female) was sleeping alone on the playing field. The cob was at the other end of Stonebow, guarding their nest. This was typical behaviour by this pair during the two weeks or so of mating and egg creation prior to incubation. Fortunately, I decided to take some photographs of the pen. A loose dog appeared, charged towards the pen from the small bridge at the north west corner of the playing field and attacked her. I intervened loudly, upon which the dog left the playing field via the same bridge. A dog owner was nowhere to be seen. Thankfully, there were no physical injuries to the pen. Some minutes later, the owner appeared on the path north of the playing field, with his dog still loose. My description of the incident and a request for the dog to be put on a lead was met with foul language and refusal.

> THE SUPPOSED OPERATION OF 'DOGS ON LEADS BY DIRECTION' ACHIEVED NOTHING.

> LOOSE DOG ATTACK INCIDENT [6] ON THE PLAYING FIELD 'ONLY' – In July 2022 a Stonebow visitor, without prompting, raised the subject of an Eastern European man with two very aggressive black dogs. I was already all too well aware of this prticular dog owner, who frequently visits Stonebow (or Dishley Pool) at the same approximate time of day. I formally reported him, his dangerous dogs and his vehicle details and registration to CBC MONTHS AGO, but determining his address is still reportedly ongoing at CBC and no other action has been taken. I still quite frequently see and hear the man shouting loudly at his dogs, usually loose, at Stonebow or Dishley Pool. The visitor said that his innocent dog had been attacked by one of the Eastern European's two dogs. He asked the Eastern European to control his dog, but was ignored. The visitor added that the same dog then attacked a group of flight-capable swan cygnets ON THE PLAYING FIELD.
**** THE SUPPOSED OPERATION OF 'DOGS ON LEADS BY DIRECTION' HAS THUS FAR ACHIEVED NOTHING, DESPITE MY FORMAL REPORT, INCLUDING VEHICLE DETAILS, PROVIDED MONTHS AGO

AND, NOT LEAST, THE CONTINUING, FREQUENT APPEARANCES OF THE OWNER AND HIS DOGS ON STONEBOW OR DISHLEY AT THE SAME APPROXIMATE TIME OF DAY, ALSO REPORTED TO CBC. THIS IS A PRIME EXAMPLE OF A COMPLETE FAILURE OF ONE OF MANY TOTALLY INEFFECTIVE ASPECTS OF 'DOGS ON LEADS BY DIRECTION' (SEE MY 16TH OCTOBER 2021 REPORT FOR COMPREHENSIVE DETAILS).

>

> LOOSE DOG ATTACK INCIDENTS [7] TO [13] ON THE PLAYING FIELD 'ONLY – At the time of writing, attacks on the playing field by the above-described Eastern European's two loose dogs have been described to me, without prompting, by SEVEN other people/couples. Those dogs are consistently described as extremely aggressive towards people, dogs and/or wildlife, yet 'DOGS ON LEADS BY DIRECTION' HAS FAILED TO ACHIEVE ANYTHING AT ALL DESPITE MY FORMAL REPORT MONTHS AGO. Almost all of the seven were of the firm opinion that the Eastern European's dogs were their prime suspects for the murder of the Stonebow Mute swan cob in April 2022. I've witnessed the man holding one of his loose dogs' collars whilst passing a group of several children playing on the playing field. He is clearly well aware of the danger his dogs pose, yet he continues to allow them to be loose and, not least, is allowed by the failure of 'Dogs on leads by direction' to have them loose.

> THE SUPPOSED OPERATION OF 'DOGS ON LEADS BY DIRECTION' HAS THUS FAR ACHIEVED NOTHING. SEE ABOVE ***.

>

> LOOSE DOG ATTACK INCIDENT [14] ON THE PLAYING FIELD 'ONLY' - 14th April 2022. The abovedescribed Eastern European was involved in an exceptionally loud episode with his dogs ON THE PLAYING FIELD. I was on Mount Grace Road, unable to immediately see what was happening, so I rushed down the slope to the playing field to investigate as the Eastern European and his loose dogs went up the slope to Lindisfarne Drive and drove off. Two youths had erected tents on the field and were looking extremely stunned and redfaced. A significant incident had clearly occurred.

> THE SUPPOSED OPERATION OF 'DOGS ON LEADS BY DIRECTION' HAS THUS FAR ACHIEVED NOTHING. SEE ABOVE ***.

>

> LOOSE DOG ATTACK INCIDENT [15] ON THE PLAYING FIELD 'ONLY' - I was walking with my bicycle across the playing field and heard loud shouting behind me. I saw two men with two loose dogs, one medium sized and the other small. The larger dog was speeding towards me. One of the men was shouting loudly at the larger dog, which ran at full speed into my legs. I felt a bite to my leg. The dog stood close, snarling, barking and snapping the air. The men did nothing, apart from continued ineffective shouting. As the men left the playing field to the west, one still shouting, the dog thankfully ran to join them. I checked my leg and could see marks but no bleeding. I checked if there were any vehicles parked at any of the eastern entrances (there were none) and the four weren't seen (or heard) again during this visit or any subsequent visits.

> THE SUPPOSED OPERATION OF 'DOGS ON LEADS BY DIRECTION' ACHIEVED NOTHING.

>

> LOOSE DOG ATTACK INCIDENT [16] ON THE PLAYING FIELD 'ONLY' - I witnessed an attack by a mediumsized dog upon a small one, both loose ON THE PLAYING FIELD. I was close and able to chase the attacking dog away, at risk to myself. The attacking dog's owner was nowhere to be seen. The small dog was left with bleeding nose and ear wounds. Not least was the worryingly extreme distress of its elderly owner. > THE SUPPOSED OPERATION OF 'DOGS ON LEADS BY DIRECTION' ACHIEVED NOTHING. >

> LOOSE DOG ATTACK INCIDENT [17] ON THE PLAYING FIELD 'ONLY' – I witnessed, more than once, a man encouraging his large dog to enter the larger pond, inducing the swan cob to react. He kept the dog on a collar connected to an extremely long length of thick strapping, to allow him to pull the dog, with alarming violence, out of the water by its neck just before the cob reached it. This behaviour by the same man and dog was also witnessed ON THE PLAYING FIELD, once as an encouraged dog attack upon a gathering of Mallard and on another occasion as an encouraged dog attack upon another dog, which led to a fight between the two owners. He hasn't been seen at Stonebow since, although that does not necessarily mean that he no longer visits.

> THE SUPPOSED OPERATION OF 'DOGS ON LEADS BY DIRECTION' ACHIEVED NOTHING.

> Other dog owners using extremely long, makeshift leads are also seen at Stonebow (and Dishley Pool). One Stonebow dog owner I spoke to, who was using a very long length of rope, said, with a grin and a nod at his dog, that '...he likes to nip other dogs'. UNBELIEVABLY, HE WAS UNASHAMEDLY ADMITTING THAT THE ROPE WAS LONG IN ORDER TO DELIBERATELY ALLOW HIS DOG THE FREEDOM TO BITE OTHER DOGS!

> EVIDENCE OF SIGNIFICANT ASB (I.E. LOOSE DOG ATTACKS) ON THE STONEBOW WASHLANDS PONDS AREA (CBC'S 'BLUE ZONE') CAUSED BY LOOSE DOGS COMING OFF THE PLAYING FIELD (CBC'S 'YELLOW ZONE').

> Of considerable relevance, the following will provide some examples (amongst many witnessed) of previously submitted written evidence to CBC of significant ASB (i.e. loose dog attacks) on the ponds area (CBC's 'blue zone') due to loose dogs COMING OFF the playing field (CBC's 'yellow zone') onto the almost immediately adjacent southern bank of the smaller pond in the ponds area. Note that there is no physical barrier, let alone a dog-proof barrier, between the playing field and the ponds area.

> FOR SOME UNIDENTIFIED REASON, THE FOLLOWING EVIDENCE HAS RECENTLY BEEN OVERLOOKED BY CBC. THEY HAVE INSTEAD DECLARED 'NO EVIDENCE' OF SIGNIFICANT ASB (I.E. LOOSE DOG ATTACKS)' ON THE PLAYING FIELD 'ONLY'. USE OF THE WORD 'ONLY' BY CBC WAS EXPLAINED EARLIER. BECAUSE OF THAT SERIOUS OVERSIGHT, THE UNREALISTICALLY LIMITING 'ONLY' STIPULATION AND A FAILURE TO RECOGNISE THE TOTAL INEFFECTIVENESS OF 'DOGS ON LEADS BY DIRECTION', CBC RECENTLY CHOSE TO CONTINUE WITH THAT SCHEME ON THE PLAYING FIELD.

> CBC HAVE YET TO EXPLAIN HOW THEY EXPECT TO PREVENT DOG ATTACKS ON THE PONDS AREA CAUSED BY DOGS ALLOWED TO BE LOOSE ON THE PLAYING FIELD UNDER THE TOTALLY INEFFECTIVE 'DOGS ON LEADS BY DIRECTION' SCHEME. IT IS (OR SHOULD BE) CLEAR FROM THE FOLLOWING EVIDENCE ALONE THAT 'DOGS ON LEADS AT ALL TIMES' ON THE PLAYING FIELD IS THE ONLY SENSIBLE SOLUTION.

> THE FOLLOWING LOOSE DOG ATTACKS CAUSED BY LOOSE DOGS COMING OFF THE STONEBOW PLAYING FIELD ONTO THE PONDS AREA ARE TAKEN FROM MY 16TH OCTOBER 2021 REPORT, WHICH DELIBERATELY ENCOMPASSED A RECORDING PERIOD OF NINETEEN MONTHS AT STONEBOW WASHLANDS. 'DOGS ON LEADS BY DIRECTION' WAS IN SUPPOSED "OPERATION" DURING THAT ENTIRE PERIOD. NUMBERING IS AS USED IN MY 16TH OCTOBER 2021 REPORT. SUBSEQUENT ATTACKS WILL ALSO BE DESCRIBED, TO DEMONSTRATE THE INEVITABLE CONTINUANCE OF THE PROBLEM. THE ONLY EFFECTIVE SOLUTION IS TO APPLY 'DOGS ON LEADS AT ALL TIMES' TO THE PLAYING FIELD.

>

> LOOSE DOG ATTACK INCIDENT 11 - Stonebow Washlands. 1st January 2021. A loose dog attack upon a

family of two adult swans and their four cygnets. CAUSED BY A LOOSE DOG COMING OFF THE STONEBOW PLAYING FIELD ONTO THE PONDS AREA.

> THE SUPPOSED OPERATION OF 'DOGS ON LEADS BY DIRECTION' ACHIEVED NOTHING.

> LOOSE DOG ATTACK INCIDENT 17 - Stonebow Washlands 25th February 2021. A loose dog attack upon four Mute swan cygnets on the southern bank of the smaller pond. CAUSED BY A LOOSE DOG COMING OFF THE STONEBOW PLAYING FIELD ONTO THE PONDS AREA.

> THE SUPPOSED OPERATION OF 'DOGS ON LEADS BY DIRECTION' ACHIEVED NOTHING.

> LOOSE DOG ATTACK INCIDENT 20 - Stonebow Washlands, 17th May 2021. A loose dog attack upon nine Mallard on the southern bank of the smaller pond. CAUSED BY A LOOSE DOG COMING OFF THE STONEBOW PLAYING FIELD ONTO THE PONDS AREA.

> THE SUPPOSED OPERATION OF 'DOGS ON LEADS BY DIRECTION' ACHIEVED NOTHING.

 > LOOSE DOG ATTACK INCIDENT 21 - Stonebow Washlands, 19th May 2021. On the southern bank of the smaller pond. An uncontrolled loose dog causing havoc, in addition to an attack upon pigeons on the bank.

 > THE SUPPOSED OPERATION OF 'DOGS ON LEADS BY DIRECTION' ACHIEVED NOTHING.

> Subsequent loose dog attacks on the southern bank of the smaller pond, CAUSED BY LOOSE DOGS COMING OFF THE STONEBOW PLAYING FIELD (CBC'S 'YELLOW ZONE') ONTO THE PONDS AREA (CBC'S 'BLUE ZONE'), have been witnessed. Some have been reported to CBC (by myself and others) and some have occurred since the introduction of 'Dogs on leads at all times' on the ponds area and 'Dogs on leads by direction' (loose dogs) on the playing field. > IN AN EMAIL DATED 11TH JULY 2022, CHARNWOOD BOROUGH COUNCIL (CBC) REQUESTED (QUOTE) '...ANY EVIDENCE OF SIGNIFICANT ASB IE DOG ATTACKS FOR THE YELLOW ZONE ONLY.'

>

> THE WORD 'ONLY' IN THE ABOVE IS APPARENTLY INTENDED BY CBC TO MEAN SIGNIFICANT ASB (I.E. DOG ATTACKS) BEGINNING, REMAINING AND ENDING ON THE PLAYING FIELD 'ONLY'. I HAVE NEVER PREVIOUSLY THOUGHT IT SENSIBLE TO ONLY REPORT SUCH SEVERELY CONSTRAINED INFORMATION, BECAUSE IT FAILS TO PROVIDE ALL OF THE AVAILABLE (AND VERY NECESSARY) EVIDENCE, WHICH COULD LEAD TO INCORRECT CONCLUSIONS. NEVERTHELESS, MY FIFTEEN THOUSAND HOURS OR SO OF OBSERVATION AT STONEBOW AND DISHLEY POOL EASILY IDENTIFY SUFFICIENT EVIDENCE OF THAT SPECIFIC TYPE OF INCIDENT, WHICH IS PROVIDED BELOW.

> I WILL ALSO REPORT SOME EXAMPLES OF INCIDENTS, INCLUDING A 2021 WILDLIFE FATALITY, CAUSED BY UNCONTROLLED LOOSE DOGS COMING OFF THE PLAYING FIELD AND INFLICTING ATTACKS ON THE PONDS AREA. NUMEROUS EXAMPLES OF SUCH HAVE BEEN WITNESSED DURING THE LAST TWELVE YEARS. IT IS INARGUABLE THAT THOSE INCIDENTS WOULD NOT HAVE OCCURRED HAD 'DOGS ON LEADS AT ALL TIMES' BEEN COMPETENTLY APPLIED TO BOTH THE PONDS AREA AND THE PLAYING FIELD. CONTINUING USE OF CBC'S 'DOGS ON LEADS BY DIRECTION' SCHEME ON THE PLAYING FIELD HAS BEEN AND STILL IS THE CAUSE OF LOOSE DOG ATTACKS ON BOTH AREAS, DUE ITS TOTAL INEFFECTIVENESS, AS PROVEN BY TWO INDEPENDENT METHODS IN MY 16TH OCTOBER 2021 REPORT.

> NUMBERING IS ARBITRARY.

>

> LOOSE DOG ATTACK INCIDENT [1] ON THE PLAYING FIELD 'ONLY' - Before being killed by a loose dog in April 2022, the Stonebow cob had already been hospitalised by the RSPCA on two separate occasions due to loose dog attacks. He barely survived the first incident. The second of those incidents was witnessed occurring ON THE PLAYING FIELD (CBC's 'yellow zone') by a visitor who called the RSPCA at the time.

>

> LOOSE DOG ATTACK INCIDENT [2] ON THE PLAYING FIELD 'ONLY' – I arrived by bicycle at the Stonebow notice board entrance at the same time as a car, which parked on Lindisfarne Drive. A door of the car swung open, a football was ejected down the entrance slope LEADING TO THE PLAYING FIELD and a loose dog leap out and chased after it. I noticed that the swan family, quite well grown, were close by ON THE PLAYING FIELD, so I began moving towards them as I shouted to ask if the dog was "OK with swans" and to advise that the swan family was on the playing field. A man emerged from the car and replied that his dog ignored the swans. A few seconds later, his dog charged into and attacked the swan family ON THE PLAYING FIELD, clearly intent upon causing injury or worse. I dropped my bike, launched into the melee, grabbed the dog's collar and pulled it away from the swan family. The owner eventually caught up, snatched the dog from me and stormed off, grim-faced, towards the ponds area without a word, as if the attack was anybody's fault but his own. I shouted for him to put his dog on a lead, which he ignored. Fortunately, there were no physical injuries to myself, the swan family or the dog.

> THE SUPPOSED OPERATION OF 'DOGS ON LEADS BY DIRECTION' ACHIEVED NOTHING.

> LOOSE DOG ATTACK INCIDENT [3] ON THE PLAYING FIELD 'ONLY' - I was leaving Stonebow along the southern path and observed one loose dog pounce upon another loose dog ON THE PLAYING FIELD and attempt rape. The owners separated them and a loud exchange began, which I didn't stay to witness.

> THE SUPPOSED OPERATION OF 'DOGS ON LEADS BY DIRECTION' ACHIEVED NOTHING.

> LOOSE DOG ATTACK INCIDENT [4] ON THE PLAYING FIELD 'ONLY' – January 2022. The adult swan pair were grazing ON THE PLAYING FIELD when two loose dogs appeared from the Mount Grace Road incline. One of the dogs immediately rushed straight for the cob. The dog was alarmingly aggressive. The dog owner said and did nothing. Fortunately, I was close to the cob, who knew and trusted me, so I was able to quickly stand between the two, albeit at very obvious risk from the aggressive dog. I shouted for the owner to control it, but she continued to ignore the situation, didn't call the dog and merely headed toward the ponds. Thankfully, the dog followed her. She entered the ponds area with both dogs still loose.

> THE SUPPOSED OPERATION OF 'DOGS ON LEADS BY DIRECTION' ACHIEVED NOTHING.

>

> LOOSE DOG ATTACK INCIDENT [5] ON THE PLAYING FIELD 'ONLY' - March 2022, the swan pen (adult female) was sleeping alone on the playing field. The cob was at the other end of Stonebow, guarding their nest. This was typical behaviour by this pair during the two weeks or so of mating and egg creation prior to incubation. Fortunately, I decided to take some photographs of the pen. A loose dog appeared, charged towards the pen from the small bridge at the north west corner of the playing field and attacked her. I intervened loudly, upon which the dog left the playing field via the same bridge. A dog owner was nowhere to be seen. Thankfully, there were no physical injuries to the pen. Some minutes later, the owner appeared on the path north of the playing field, with his dog still loose. My description of the incident and a request for the dog to be put on a lead was met with foul language and refusal.

> THE SUPPOSED OPERATION OF 'DOGS ON LEADS BY DIRECTION' ACHIEVED NOTHING.

>

> LOOSE DOG ATTACK INCIDENT [6] ON THE PLAYING FIELD 'ONLY' – In July 2022 a Stonebow visitor, without prompting, raised the subject of an Eastern European man with two very aggressive black dogs. I was already all too well aware of this prticular dog owner, who frequently visits Stonebow (or Dishley Pool) at the same approximate time of day. I formally reported him, his dangerous dogs and his vehicle details and registration to CBC MONTHS AGO, but determining his address is still reportedly ongoing at CBC and no other action has been taken. I still quite frequently see and hear the man shouting loudly at his dogs, usually loose, at Stonebow or Dishley Pool. The visitor said that his innocent dog had been attacked by one of the Eastern European's two dogs. He asked the Eastern European to control his dog, but was ignored. The visitor added that the same dog then attacked a group of flight-capable swan cygnets ON THE PLAYING FIELD.

> *** THE SUPPOSED OPERATION OF 'DOGS ON LEADS BY DIRECTION' HAS THUS FAR ACHIEVED NOTHING, DESPITE MY FORMAL REPORT, INCLUDING VEHICLE DETAILS, PROVIDED MONTHS AGO AND, NOT LEAST, THE CONTINUING, FREQUENT APPEARANCES OF THE OWNER AND HIS DOGS ON STONEBOW OR DISHLEY AT THE SAME APPROXIMATE TIME OF DAY, ALSO REPORTED TO CBC. THIS IS A PRIME EXAMPLE OF A COMPLETE FAILURE OF ONE OF MANY TOTALLY INEFFECTIVE ASPECTS OF 'DOGS ON LEADS BY DIRECTION' (SEE MY 16TH OCTOBER 2021 REPORT FOR COMPREHENSIVE DETAILS).

>

> LOOSE DOG ATTACK INCIDENTS [7] TO [13] ON THE PLAYING FIELD 'ONLY – At the time of writing, attacks on the playing field by the above-described Eastern European's two loose dogs have been described to me, without prompting, by SEVEN other people/couples. Those dogs are consistently described as extremely aggressive towards people, dogs and/or wildlife, yet 'DOGS ON LEADS BY DIRECTION' HAS FAILED TO ACHIEVE ANYTHING AT ALL DESPITE MY FORMAL REPORT MONTHS AGO. Almost all of the seven were of the firm opinion that the Eastern European's dogs were their prime suspects for the murder of the Stonebow Mute swan cob in April 2022. I've witnessed the man holding one of his loose dogs' collars whilst passing a group of

several children playing on the playing field. He is clearly well aware of the danger his dogs pose, yet he continues to allow them to be loose and, not least, is allowed by the failure of 'Dogs on leads by direction' to have them loose.

> THE SUPPOSED OPERATION OF 'DOGS ON LEADS BY DIRECTION' HAS THUS FAR ACHIEVED NOTHING. SEE ABOVE ***.

>

> LOOSE DOG ATTACK INCIDENT [14] ON THE PLAYING FIELD 'ONLY' - 14th April 2022. The above-described Eastern European was involved in an exceptionally loud episode with his dogs ON THE PLAYING FIELD. I was on Mount Grace Road, unable to immediately see what was happening, so I rushed down the slope to the playing field to investigate as the Eastern European and his loose dogs went up the slope to Lindisfarne Drive and drove off. Two youths had erected tents on the field and were looking extremely stunned and red-faced. A significant incident had clearly occurred.

> THE SUPPOSED OPERATION OF 'DOGS ON LEADS BY DIRECTION' HAS THUS FAR ACHIEVED NOTHING. SEE ABOVE ***.

>

> LOOSE DOG ATTACK INCIDENT [15] ON THE PLAYING FIELD 'ONLY' - I was walking with my bicycle across the playing field and heard loud shouting behind me. I saw two men with two loose dogs, one medium sized and the other small. The larger dog was speeding towards me. One of the men was shouting loudly at the larger dog, which ran at full speed into my legs. I felt a bite to my leg. The dog stood close, snarling, barking and snapping the air. The men did nothing, apart from continued ineffective shouting. As the men left the playing field to the west, one still shouting, the dog thankfully ran to join them. I checked my leg and could see marks but no bleeding. I checked if there were any vehicles parked at any of the eastern entrances (there were none) and the four weren't seen (or heard) again during this visit or any subsequent visits.

> THE SUPPOSED OPERATION OF 'DOGS ON LEADS BY DIRECTION' ACHIEVED NOTHING.

>

> LOOSE DOG ATTACK INCIDENT [16] ON THE PLAYING FIELD 'ONLY' - I witnessed an attack by a medium-sized dog upon a small one, both loose ON THE PLAYING FIELD. I was close and able to chase the attacking dog away, at risk to myself. The attacking dog's owner was nowhere to be seen. The small dog was left with bleeding nose and ear wounds. Not least was the worryingly extreme distress of its elderly owner.

> THE SUPPOSED OPERATION OF 'DOGS ON LEADS BY DIRECTION' ACHIEVED NOTHING.

>

> LOOSE DOG ATTACK INCIDENT [17] ON THE PLAYING FIELD 'ONLY' – I witnessed, more than once, a man encouraging his large dog to enter the larger pond, inducing the swan cob to react. He kept the dog on a collar connected to an extremely long length of thick strapping, to allow him to pull the dog, with alarming violence, out of the water by its neck just before the cob reached it. This behaviour by the same man and dog was also witnessed ON THE PLAYING FIELD, once as an encouraged dog attack upon a gathering of Mallard and on another occasion as an encouraged dog attack upon another dog, which led to a fight between the two owners. He hasn't been seen at Stonebow since, although that does not necessarily mean that he no longer visits. > THE SUPPOSED OPERATION OF 'DOGS ON LEADS BY DIRECTION' ACHIEVED NOTHING.

>

> Other dog owners using extremely long, makeshift leads are also seen at Stonebow (and Dishley Pool). One Stonebow dog owner I spoke to, who was using a very long length of rope, said, with a grin and a nod at his dog, that '...he likes to nip other dogs'. UNBELIEVABLY, HE WAS UNASHAMEDLY ADMITTING THAT THE ROPE WAS LONG IN ORDER TO DELIBERATELY ALLOW HIS DOG THE FREEDOM TO BITE OTHER DOGS!

>

> EVIDENCE OF SIGNIFICANT ASB (I.E. LOOSE DOG ATTACKS) ON THE STONEBOW WASHLANDS PONDS AREA (CBC'S 'BLUE ZONE') CAUSED BY LOOSE DOGS COMING OFF THE PLAYING FIELD (CBC'S 'YELLOW ZONE').

>

> Of considerable relevance, the following will provide some examples (amongst many witnessed) of previously submitted written evidence to CBC of significant ASB (i.e. loose dog attacks) on the ponds area (CBC's 'blue zone') due to loose dogs COMING OFF the playing field (CBC's 'yellow zone') onto the almost immediately adjacent southern bank of the smaller pond in the ponds area. Note that there is no physical barrier, let alone a dog-proof barrier, between the playing field and the ponds area.

>

> FOR SOME UNIDENTIFIED REASON, THE FOLLOWING EVIDENCE HAS RECENTLY BEEN OVERLOOKED BY CBC. THEY HAVE INSTEAD DECLARED 'NO EVIDENCE' OF SIGNIFICANT ASB (I.E. LOOSE DOG ATTACKS)' ON THE PLAYING FIELD 'ONLY'. USE OF THE WORD 'ONLY' BY CBC WAS EXPLAINED EARLIER. BECAUSE OF THAT SERIOUS OVERSIGHT, THE UNREALISTICALLY LIMITING 'ONLY' STIPULATION AND A FAILURE TO RECOGNISE THE TOTAL INEFFECTIVENESS OF 'DOGS ON LEADS BY DIRECTION', CBC RECENTLY CHOSE TO CONTINUE WITH THAT SCHEME ON THE PLAYING FIELD.

> CBC HAVE YET TO EXPLAIN HOW THEY EXPECT TO PREVENT DOG ATTACKS ON THE PONDS AREA CAUSED BY DOGS ALLOWED TO BE LOOSE ON THE PLAYING FIELD UNDER THE TOTALLY INEFFECTIVE 'DOGS ON LEADS BY DIRECTION' SCHEME. IT IS (OR SHOULD BE) CLEAR FROM THE FOLLOWING EVIDENCE ALONE THAT 'DOGS ON LEADS AT ALL TIMES' ON THE PLAYING FIELD IS THE ONLY SENSIBLE SOLUTION. > THE FOLLOWING LOOSE DOG ATTACKS CAUSED BY LOOSE DOGS COMING OFF THE STONEBOW PLAYING FIELD ONTO THE PONDS AREA ARE TAKEN FROM MY 16TH OCTOBER 2021 REPORT, WHICH DELIBERATELY ENCOMPASSED A RECORDING PERIOD OF NINETEEN MONTHS AT STONEBOW WASHLANDS. 'DOGS ON LEADS BY DIRECTION' WAS IN SUPPOSED "OPERATION" DURING THAT ENTIRE PERIOD. NUMBERING IS AS USED IN MY 16TH OCTOBER 2021 REPORT. SUBSEQUENT ATTACKS WILL ALSO BE DESCRIBED, TO DEMONSTRATE THE INEVITABLE CONTINUANCE OF THE PROBLEM. THE ONLY EFFECTIVE SOLUTION IS TO APPLY 'DOGS ON LEADS AT ALL TIMES' TO THE PLAYING FIELD.

>

> LOOSE DOG ATTACK INCIDENT 11 - Stonebow Washlands. 1st January 2021. A loose dog attack upon a family of two adult swans and their four cygnets. CAUSED BY A LOOSE DOG COMING OFF THE STONEBOW PLAYING FIELD ONTO THE PONDS AREA.

> THE SUPPOSED OPERATION OF 'DOGS ON LEADS BY DIRECTION' ACHIEVED NOTHING.

>

LOOSE DOG ATTACK INCIDENT 17 - Stonebow Washlands 25th February 2021. A loose dog attack upon four Mute swan cygnets on the southern bank of the smaller pond. CAUSED BY A LOOSE DOG COMING OFF THE STONEBOW PLAYING FIELD ONTO THE PONDS AREA.

> THE SUPPOSED OPERATION OF 'DOGS ON LEADS BY DIRECTION' ACHIEVED NOTHING.

>

LOOSE DOG ATTACK INCIDENT 20 - Stonebow Washlands, 17th May 2021. A loose dog attack upon nine Mallard on the southern bank of the smaller pond. CAUSED BY A LOOSE DOG COMING OFF THE STONEBOW PLAYING FIELD ONTO THE PONDS AREA.

> THE SUPPOSED OPERATION OF 'DOGS ON LEADS BY DIRECTION' ACHIEVED NOTHING.

>

> LOOSE DOG ATTACK INCIDENT 21 - Stonebow Washlands, 19th May 2021. On the southern bank of the smaller pond. An uncontrolled loose dog causing havoc, in addition to an attack upon pigeons on the bank. CAUSED BY A LOOSE DOG COMING OFF THE STONEBOW PLAYING FIELD ONTO THE PONDS AREA.
> THE SUPPOSED OPERATION OF 'DOGS ON LEADS BY DIRECTION' ACHIEVED NOTHING.

>

> LOOSE DOG ATTACK INCIDENT 24 - Stonebow Washlands, on the southern bank of the smaller pond, 29th June 2021. A very young Mallard duckling was killed during a loose dog induced incident. CAUSED BY A LOOSE DOG COMING OFF THE

STONEBOW PLAYING FIELD ONTO THE PONDS AREA. > THE SUPPOSED OPERATION OF 'DOGS ON LEADS BY DIRECTION' ACHIEVED NOTHING. >

> Subsequent loose dog attacks on the southern bank of the smaller pond, CAUSED BY LOOSE DOGS COMING OFF THE STONEBOW PLAYING FIELD (CBC'S 'YELLOW ZONE') ONTO THE PONDS AREA (CBC'S 'BLUE ZONE'), have been witnessed. Some have been reported to CBC (by myself and others) and some have occurred since the introduction of 'Dogs on leads at all times' on the ponds area and 'Dogs on leads by direction' (loose dogs) on the playing field. My report of an attack on 4th June 2022 and a visitor report of an incident on 8th June 2022 (held on file) are easily recalled examples, although there have been others.

> THE SUPPOSED OPERATION OF 'DOGS ON LEADS BY DIRECTION' ON THE PLAYING FIELD ACHIEVED NOTHING.
