1. Background

- 1.1 This application has been brought to plans committee as it relates to a major housing development, outside current limits to development and is considered a departure from the development plan and is recommended for approval. The application has also been called in by Ward Cllr Fryer and Ward Cllr Ranson for the following reasons:
 - Overdevelopment
 - Outside limits to development
 - Loss of agricultural land
 - Access

2. Description of the Application Site

- 2.1 The site is situated on the southern side of Melton Road. The site is roughly rectangular in shape and is approximately 7.02 hectares in size. The site includes Melton Road to the north-west. The site is adjacent to a belt of trees along the western boundary (which separate the site from Seagrave Nurseries) and open countryside to the south and east. Opposite the site to the north is a field currently subject to planning application P/21/0759/2 for up to 135 dwellings, also on this Plans Committee agenda.
- 2.2 The nearest residential properties are those on the edge of Barrow Upon Soar (west of Fishpool Way) approximately 100m to the north-west and the Poppyfields development 100m to the west. The site is also over 50m away from two farms on Melton Road to the north-east and east.
- 2.3 The site is currently accessed from the access track that runs along the eastern boundary of the site and is accessed from Melton Road. The access track and access point are not within the site boundary. The site itself is currently agricultural land and is varied in topography. The site levels rise gently southwest to south-east along Melton Road. Within the site, the levels fall from Melton Road initially and the rise to the south, whereby the southern boundary of the site is not visible from Melton Road. Levels at Melton Road are 53.54m

AOD and increase to 70.42m AOD. The site has a ditch and hedgerow boundary along Melton Road, no boundary to the east (the boundary is an agricultural track with hedgerow beyond) and a post and wire fence with limited hedge to the southern boundary.

- 2.4 The site is close to existing footpaths and bridleways. The public bridleway I20/3 runs parallel to the western boundary, within the belt of trees and roughly follows the eastern outskirts of settlement. The public footpath I23/3 runs along the southern boundary (outside the site) from Barrow to Big Lane to the east.
- 2.5 The site is outside the defined Limits to Development of Barrow Upon Soar. The site has no landscape designations. The site is located within the Soar Valley Landscape Character Area and adjacent to the Clay Wolds Landscape Character Area to the east.

3. Description of the Proposal

- 3.1 This outline planning application seeks planning permission for the erection of up to 130 dwellings, with all matters reserved other than the access onto Melton Road. The proposal includes 30% affordable housing. The proposed density of the residential areas would be an average of 35 dwellings per hectare.
- 3.2 It is proposed that the access would be taken from Melton Road. The submitted Development Framework plan shows housing would be set back approximately 70m from Melton Road, with open space (including a Local Equipped Area of Play (LEAP)) and a drainage attenuation pond adjacent to Melton Road, at the lowest point of the site. A pedestrian footpath is shown within the site, linking the open space next to Melton Road with open space to the south of the site. The footpath link would also enable a connection to the existing public footpath (123/3) which runs adjacent to the southern boundary. The Development Framework Plan shows open space and tree and woodland planting to the south of the site where the site abuts open countryside and the public footpath 123/3. The eastern boundary to open countryside is to include a 10m wide landscape buffer enhanced with woodland planting and meadow. All existing hedgerow boundaries are proposed to be retained, with the exception of a section of the northern hedgerow, which is to be removed to facilitate the new access point.
- 3.3 To connect the development to the existing urban area of Barrow Upon Soar, there are two pedestrian crossings proposed: one across Melton Road; and the second by the existing Melton Road/Fishpool Way roundabout.

- 3.5 During the processing of the application, the applicant submitted further highway information, and this was re-consulted upon with the Local Highway Authority. A Biodiversity Impact Assessment (BIA) was also submitted and the Senior Ecologist was consulted.

4. Pre-application Advice

- 4.1 No pre-application advice was sought regarding this proposal.
- 4.2 Environmental Impact Assessment (EIA) Screening:

The proposal is for urban development of less than 150 dwellings, but the site area is over 5 hectares. The development therefore falls under Schedule 2 of the Town and Country Planning (Environmental Impact Assessment) (England and Wales) Regulations 2017 (as amended). EIA is unlikely to be required for the redevelopment of land unless it is of a significantly greater scale with significant urbanising effects (e.g. 1,000 dwellings) or the types of impact are of a markedly different nature or there is a high level of contamination. Given the nature of the application proposals, it is not considered that the application would constitute EIA development.

9. Consideration of the Planning Issues

- 9.1 The starting point for decision making on all planning applications is that they must be made in accordance with the adopted Development Plan unless material considerations indicate otherwise. The most relevant policies for the determination of this application are listed above and are contained within the Development Plan for Charnwood which comprises the Core Strategy (2015) and those "saved" policies within the Borough of Charnwood Local Plan 1991-2026 (2004) which have not been superseded by the Core Strategy (2011-2028), the Minerals and Waste Local Plan (2019) and the Barrow upon Soar Neighbourhood Plan (2018).
- 9.2 The Core Strategy and Charnwood Local Plan are over 5 years old, and it is important to take account of changing circumstances affecting the area, or any

relevant changes in national policy. Other than those policies which relate to the supply of housing, the relevant policies listed above are up to date and compliant with national guidance and as such that there is no reason for them to be given reduced weight.

- 9.3 As the Core strategy is now five years old, the Planning Authority cannot currently demonstrate a 5-year supply of housing land (3.04 years at 31/3/22) and, as a result, any policies which directly relate to the supply of housing are out of date and cannot be afforded full weight. The shortfall in the supply of deliverable housing sites also means that, in accordance with the presumption in favour of sustainable development (at paragraph 11d of the NPPF), any adverse impacts caused by the proposal must significantly and demonstrably outweigh its benefits for planning permission to be refused.
- 9.4 Part i) of NPPF paragraph 11d) sets out that where there are NPPF policies that protect areas or assets this can be a clear reason to refuse an application. These are generally nationally designated areas such as SSSI's, designated Local Green Space, AONBs and designated heritage assets. In this case, the site is not in an area specifically protected by the NPPF such that the NPPF's presumption in favour of sustainable development and the 'tilted balance' applies.
- 9.5 As the Barrow upon Soar Neighbourhood Plan was made in 2018 it is more than 2 years old and cannot rely on the provisions of para 14 of the NPPF. Therefore, its policies relating to the provision of housing are also not considered to be up to date.
- 9.6 The main issues for this application are considered to be:
 - The Principle of Development
 - Housing Mix
 - Landscape and Visual Impact
 - Design and Layout
 - Open Space
 - Ecology and Biodiversity
 - Impact on residential amenity
 - Noise, Air Quality and Contamination
 - Heritage impacts
 - Highway Matters
 - Flooding and drainage
 - Sustainable construction and energy efficiency
 - S106 Contributions

9.7 The Principle of the Development

9.7.1 The application site is located outside of, but close to, the defined Limits to Development, as defined in the Barrow Upon Soar Neighbourhood Plan

(Policies Map page 64). The Limits to Development include the Millennium Park to the west of the north-west of the site and the recent housing development to the south-west of the site, but not the Seagrave Nurseries adjacent to the site. Therefore, as the land is countryside, saved policy CT/1 applies. Policy CT/1 sets out that development in the countryside will be strictly controlled, and planning permission will be granted for certain types of development only. Major housing development is not one of those developments permitted by CT/1. The proposal is therefore contrary to policy CT/1.

- 9.7.2 Saved policy CT/2 applies to development acceptable in principle, and states that development will be permitted where it does not harm the character and appearance of the countryside and safeguards its historic, nature conservation, amenity and other local interest. These matters are considered later in this report.
- 9.7.3 Policy CS1 of the Core Strategy outlines a sustainable development strategy for the Borough, based a five-tier settlement hierarchy; (1) Leicester Principal Urban Area, (2) Loughborough and Shepshed, (3) Service Centres, (4) other settlements an (5) small villages and hamlets. Within the settlement hierarchy, Barrow Upon Soar is identified as a Service Centre. The policy identifies 7 Service Centres and states that they will together provide at least 3,000 new homes to be located within and adjoining the Service Centres. The policy also states that the Borough will plan positively for the role of these settlements, by responding positively to sustainable development, contributing towards meeting development needs, support the strategic vision, make effective use of land and ensure development is in accordance with the Core Strategy. The 3,000 homes target within the policy is a minimum figure. The site is very close to the defined Limits to Development, which include the Millennium Park which lies opposite the north-western site boundary, on the opposite side of Melton Road, however the site is not directly adjoining the boundary of the settlement. Policy CS1 does not define the term 'adjoining' Service Centres. The proposal is close to the defined Limits to Development, but separated from the adjacent built form of Seagrave Nurseries by the existing tree belt. Therefore, the proposed development is considered to be close to Barrow Upon Soar but not adjoining. The proposal would therefore not be in accordance with policy CS1.
- 9.7.4 The supporting text to policy CS1 (paragraph 4.45) sets out that there are commitments for around 3,500 new homes in Service Centres and that 'this is sufficient to meet the levels of planned provision and we only expect to see small scale windfall developments within the settlement boundaries between 2014 and 2018'. Therefore, as a large housing proposal outside to Limits to Development, the current proposal is not what was envisaged for Service Centres, as clearly expressed in the supporting text to the policy. Latest monitoring shows the level of development currently expected at Service Centres exceeds the minimum requirement of 3,000 dwellings set out in policy CS1.
- 9.7.5 Policy BuS16 of the Neighbourhood Plan sets out that the minimum housing provision for 2011-2028 for the seven Service Centres set out in the Core

Strategy has been met and makes no further housing allocations for Barrow Upon Soar. The Neighbourhood Plan does not include an assessment of the housing needs of Barrow upon Soar or provide a housing requirement for the neighbourhood area. Policy BuS16 supports development within Limits to Development only, subject to criteria. Infrastructure capacity is discussed later in this report.

- 9.7.6 It is acknowledged that the level of housing development that has taken place at Service Centres has exceeded the minimum requirement of 3,000 dwellings, but that figure is a minimum. The proposal is contrary to policies CS1, CT/1 and BuS16 as it comprises a major housing development that is outside and not adjoining the Service Centre.
- 9.7.7 The NPPF is a material consideration in the determination of this application. As set out above, the application involves the provision of housing and the shortfall in the supply of deliverable housing sites means that the presumption in favour of sustainable development paragraph 11d of the NPPF is triggered. This means granting permission unless:
 - i. The application of policies in this Framework that protect areas or assets of particular importance provides clear reason for refusing the application; or
 - ii. Any adverse impacts of doing so would significantly and demonstrably outweigh the benefits, when assessed against the policies in the NPPF taken as a whole.
- 9.78 In situations where paragraph 11d of the NPPF applies, paragraph 14 of the NPPF can apply to housing proposals that conflict with the Neighbourhood Plan. In this instance, paragraph 14 is not considered to apply as all parts (a) to (d) of paragraph 14 are not satisfied (the Neighbourhood Plan is over 2 years old and does not contain an allocation to meet a defined requirement).
- 9.7.9 The emerging Charnwood Local Plan 2021-37 Pre-Submission Draft is a material consideration. The Plan is currently under examination. The emerging Plan proposes to allocate the site for 130 dwellings under policy DS3 (site HA45). The site has been identified for allocation and therefore the Council has proposed that the site is a suitable location for housing growth. The policy has been submitted for Examination and so the policy is at an advanced stage in the plan making process. The site has been assessed in the plan making process for its consistency with national policy. However, there are outstanding objections to the policy that will be considered at the examination hearing sessions in early 2023. Therefore, in accordance with paragraph 48 of the NPPF the emerging policy can be given only limited to moderate weight at this time.
- 9.7.10 Emerging Local Plan policy DS3(HA45) supports development proposals at this site that contribute to the reasonable costs of the provision of a new 1 form entry primary school located at site HA49 (Land off Cotes Road, Barrow upon Soar). Since the submission of the Local Plan, it has been agreed by the promoters of development sites at Barrow upon Soar (sites HA45, HA46, HA47, HA48 and HA49), the County Council and the Borough Council, that the primary

school will be located on site HA48 (land off Willow Road). Therefore, there is a current pending application on the HA48 site for 220 dwellings and a primary school (reference P/21/2400/2). It is noted that policy BuS10 of the Neighbourhood Plan supports the delivery of an additional primary school outside limits to development where it would be well connected to the village and accessible by non-car modes. The promoters of the development sites have agreed an Education Delivery Strategy with the County Council and the Borough Council to ensure that all proposed housing allocation sites at Barrow upon Soar will contribute to the delivery of a new primary school at Barrow upon Soar. The agreed Education Delivery Strategy is attached at Appendix A. The contribution that this proposal will make towards the new primary school is discussed later in this report under Planning Obligations. With an appropriate contribution, the proposal will satisfy emerging policy DS3(HA45).

9.7.11 In conclusion, the proposal accords with emerging policy DS3(HA45) but is contrary to Core Strategy policy CS1, Local Plan policy CT/1 and BuS16 of the Neighbourhood Plan. The development would result in 130 new dwellings at a time when the Local Planning Authority cannot demonstrate a five-year supply of housing land. Weighed against this benefit would be the conflict with the above policies which can be considered as an adverse impact. However, given the 5 year supply position of the Borough Council and the age of policies CS1, CT/1 and BuS16, the weight that can be ascribed to them is reduced. The presumption in favour of sustainable development applies to this proposal. The conflict with the Development Plan will be weighed in the planning balance with the presumption in favour of sustainable development.

9.8 Housing Mix

- 9.8.1 Core Strategy Policy CS3 outlines a requirement to secure an appropriate mix of types, tenure and sizes of homes having regard to the identified housing needs and the character of the area. The policy requires 30% affordable housing, to be built on site and integrated with market housing. The Housing Supplementary Planning Document provides further guidance in support of this relating to how these units should be provided. Neighbourhood Plan Policy BuS17 states that new housing development should provide a mix of housing types, informed by the most up to date evidence of housing need, in particular the needs of older households.
- 9.8.2 These policies generally accord with the National Planning Policy Framework and do not frustrate the supply of housing. As a result, it is not considered that there is a need to reduce the weight that should be given to them.
- 9.8.3 Emerging Local Plan policy H1 seeks a mix of house types, tenures and sizes to meet overall needs in the Borough in line with up to date evidence. Policy H2 seeks at least 10% of new market homes on major sites to meet Building Regulations Part M4(2) standards for accessible and adaptable and an appropriate proportion of affordable homes to meet M4(2) and/or M4(3). Policy H4 seeks 30% affordable housing from major housing developments (67% affordable homes for rent and 33% affordable homes for ownership).

- 9.8.4 The proposal is in outline and includes an undertaking to provide 39 affordable homes (30%). The tenure mix proposed is 77% for affordable rent (30) and 23% shared ownership (9) as required by the Supplementary Planning Document. The size, type, and design of these are not currently known and will be established by later reserved matters. At outline stage the tenure for the affordable housing will be secured through s106 legal agreement.
- 9.8.5 The Leicestershire Housing and Economic Needs Assessment (HENA) 2022 outlines a recommended housing mix for the Borough in respect of both market and affordable housing. This includes the following housing mix:

A planning condition can be applied to secure that the mix of dwellings on the site reflects the most up to date evidence of need in the Assessment.

- 9.8.6 A planning condition is also recommended to secure development in accordance with the new Building Regulations standards, as the emerging policy H1 is at an advanced stage, is in accordance with the NPPF paragraph 130 and has limited objections. This condition has been recently been accepted by the Planning Inspectorate as being reasonable and necessary for emerging allocation DS3(HA15) (application P/21/0550/2, appeal decision APP/X2410/W/21/3289048 dated 18/11/22).
- 9.8.7 With the suggested S106 obligation and planning conditions it is considered that the proposal would accord with policy CS3 of Core Strategy and BuS17 of the Neighbourhood Plan, and emerging policies H1, H2 and H4 of the Local Plan could be achieved. The provision of 41 affordable units is also a significant benefit of the scheme which should be given positive weight within the planning balance.

9.9 Landscape and Visual Impact

9.9.1 Core Strategy Policy CS2 requires high quality design and new developments

to make a positive contribution to Charnwood. New developments are required to respect and enhance the character of the area. Saved Local Plan Policy EV/1 supports new development that respects and enhances the local environment, form and function of existing settlements and undeveloped nature of the countryside. New development should safeguard important views, landmarks and skylines and use the landform and existing features as the focus around which new development should be designed. Core Strategy Policies CS11 and saved Local Plan policy CT/2 seek to protect landscape character and countryside and reinforce sense of place and local distinctiveness by taking account of local Landscape Character Assessments. These policies generally accord with the NPPF and do not directly frustrate the delivery of housing. As a result, it is not considered that there is a need to reduce the weight given to these policies.

- 9.9.2 There are no specific landscape designations for the site. The site is located within both The Soar Valley Local Landscape Character Areas and adjacent to The Wolds Local Landscape Character Area to the east. Key characteristics of these areas include low woodland cover, open countryside, extensive views from ridgeline roads, regular shaped fields and hedgerow field boundaries. The Wolds character area acknowledges that new housing to the east of Barrow upon Soar will extend the influence of these Soar Villages into the Wolds (Borough of Charnwood Landscape Character Assessment 2012, para 7.82) into the gently rolling countryside. The guidelines for these Character Areas are to generally conserve and enhance the rural character of the area and conserve long distance views of the crest of ridges, focus built development within valleys and away from valley slopes, conserve landscape features, encourage the planting of new hedgerows/woodland and the creation of pond habitats and enhance tree cover in field boundaries.
- 9.9.3 The site is proposed to be allocated for housing in the emerging Local Plan and so the site was assessed in the SHLAA sites assessment 2019 (site PSH391). The assessment notes that PSH391 is influenced by human activity (the chimney stack at British Gypsum is visible from the site) and the proximity to the eastern edge of Barrow upon Soar. Overall, the landscape sensitivity is considered to be medium for 2-3 storey development.
- 9.9.4 Public comments have raised concern regarding the loss of green space and that the site is poorly related to the village in landscape terms.
- 9.9.5 The site is bound by a hedgerow to the north (adjacent to Melton Road), a tree belt to the west, post and wire fence with minimal hedgerow to the south, and a farm track to the east. The site rises from north (Melton Road) to the south from 53m AOD to 70m AOD within the site. The Landscape and Visual Assessment has assessed a proposed development of a maximum of 2.5 storeys.
- 9.9.6 The application is supported by a Landscape and Visual Assessment (LVA), 2021. The scope of the assessment was informed by desk study and field assessment. The Landscape and Visual Assessment considers that the site and immediate landscape are of community value.

- 9.9.7 The Landscape and Visual Assessment concludes that the site has a medium susceptibility to change, given that there is similar built development in the landscape, some existing vegetation screening and good opportunities for mitigation. Due to the community value level of the site, the site was judged to be of medium to low susceptibility and low sensitivity. The Landscape and Visual Assessment concludes that the overall impact on landscape character of the local Wolds and Soar Valley landscape character areas will be minor adverse in a limited geographical area, and negligible/minor adverse during construction and minor adverse to negligible as a whole by year 15 of the development. The Landscape and Visual Assessment concludes this because of the retention of existing features and the proposed native tree and hedgerow planting within the site and on the site boundaries, which will aid screening from adjacent public rights of way. The Landscape and Visual Assessment assumes that the dwellings will respond to the topography of the site and will follow the existing site levels.
- 9.9.8 The Landscape and Visual Assessment identified and assessed 10 viewpoints that are representative of views experienced by key visual receptors. These included users of the nearby Millennium Park, users of footpaths and bridleways, nearby residents of the recent Poppyfields development to the west and properties to the north (148 Nottingham Road, Tithe Farm and Paudy Rise Farm) and motorists on nearby roads. All views were considered to be of medium sensitivity. The Landscape and Visual Assessment concludes that during construction there will be a major adverse visual impact on the users of Melton Road and the users of I23/3 (to the south). There will be moderate adverse impacts on users of bridleways 120/2 and 120/3 during construction.
- 9.9.9 The Landscape and Visual Assessment concludes that during operation of the development there is only three locations where there would be major adverse overall effects on views; viewpoints 6, (users of Melton Road), 3 and 7 (users of footpath I23/3 to the south and east). The major adverse impact would be present at year 1, but by year 15 of the development the visual impact would be reduced to moderate adverse from both Melton Road and footpath 123/3.
- 9.9.10 There are 2 viewpoints where there will be a moderate adverse effect on views in year 1: views 4 and 5 (users of bridleway I20/3 in the tree belt to the west); and view 9 (users of bridleway 120/4 to the north-west). The Landscape and Visual Assessment concludes that planting would decrease this effect to minor adverse within 15 years. Other viewpoints are considered to have a minor adverse to negligible effect by year 15. The Landscape and Visual Assessment concludes that the retention of boundary vegetation, landscape mitigation and setting back buildings from the southern edge of the site will create a sensitive transition to the wider landscape and respond to the identified landscape and visual effects.
- 9.9.11 The Council's Landscape Officer has considered the Landscape and Visual Assessment, arboricultural report and the Development Framework Plan. The officer notes that the Arboricultural report and development framework plan indicate tree protection based on root protection areas and structural stand-off

(TEP Arboricultural report para 7.9-7.10). However, at reserved matters stage the layout will need to consider the mature size (height/spread) of the adjacent tree belt, and housing to the west of the site will could experience long afternoon and evening shadow. Any shadow path analysis should take an average height of 35-40m in height into account. The tree planting is open and disperse for the public open spaces which lies adjacent to Melton Road to the south of the site. Ideally, more tree planting should be provided. There are prominent views across Barrow-upon-Soar from elevated parts of the site. Careful consideration should be given to these during the layout and detailed design stage.

9.9.12 The Landscape Officer therefore recommends:

- Condition that the layout includes tree planting of large and very high canopy trees to the open space
- Condition that the open space be provided to the more elevated area of the site
- Condition that the layout includes the main access is wide verged to accommodate medium stature trees
- Condition to secure the protection of the trees to the west
- Condition to secure landscaping and tree planting
- 9.9.13 The Landscape Officer has also considered the proposed development opposite the site (P/21/0759/2) and comments on that application recognises the cumulative impact of the two proposals. Cumulatively the two developments will bring built development further into the classic rhythmic pastoral landform and substantial tree planting on both of the sites will be important to mitigate this impact.
- 9.9.14 In conclusion, there would be a minor adverse to negligible impact on landscape character as a whole by year 15 of the development. The major adverse visual impacts of the development from the nearest public areas can be reduced by mitigation to moderate adverse, which can be secured by condition and incorporated into the development at reserved matters stage. It is therefore considered that that a scheme could be designed which accords with Core Strategy policies CS2 and CS11 and Local Plan policies EV/1 and CT/2 in this regard.

9.10 Design and Layout

9.10.1 Core Strategy Policy CS2 seeks high quality design for new development, to inclusive design and result in places where people wish to live. New development should respect and enhance the character of the area having regard to scale, density, massing, height, landscape, layout, materials and access arrangements, function well and add to the quality of an area. Development should provide attractive, well managed and safe public and private spaces. Save Local Plan Policy EV/1 also seeks a high standard of design and development to provide positive and attractive built frontages to public spaces and roads, footpaths and open spaces. Policy BuS4 of the Neighbourhood Plan requires new development to reflect the guidance in the Village Design Statement. The Design SPD sets out design principles

- for Charnwood and guidance on designing a major development. These policies generally accord with the National Planning Policy Framework and do not frustrate the supply of housing. As a result, it is not considered that there is a need to reduce the weight that should be given to them.
- 9.10.2 The detail of the design and layout of the proposal is a reserved matter and is not to be considered at this outline stage. The Development Framework plan and Illustrative Open Space Plan show open space could be located to the north of the site, adjacent to Melton Road. Dwellings will be set back from Melton Road, fronting onto open space, the LEAP and the attenuation pond. Adjacent to Melton Road would be a mix of amenity space and species rich grassland. A spine road will run through the site, with minor roads leading from it. Housing will be set back from Melton Road, the east and west site boundaries and these edges would be amenity space and grassland. The southern part of the site is the highest point, where further open space will be provided in the form of informal recreation provision, grassland and tree/woodland planting. The plan shows indicative tree planting along the roads within the site, as advocated by NPPF paragraph 131. A pedestrian footpath route is shown within the site, linking Melton Road to the public footpath I23/3 adjacent to the southern boundary. The layout also includes a central open space referred to as a pocket park.
- 9.10.3 The Design and Access Statement states that the context is 1 and 2 storey dwellings, but 2.5 may be considered. Due to the land levels and landscape impact, 2.5 storey will need to be carefully assessed at reserved matters stage. The appearance/design of the dwellings will be considered at reserved matters stage.
- 9.10.4 At this outline stage it is considered that the submitted details show an appropriate layout can be secured, that accommodates the required level of on-site open space. The layout will need to be refined at reserved matters stage to include tree planting and green infrastructure to the boundaries, as recommended by the landscape officer, following consideration of the submitted Landscape and Visual Assessment (LVA). Therefore, it is considered that a development that complies with NPPF, National Design Guide, Core Strategy policy CS2, saved Local Plan policy EV/1, the Design SPD and policy BuS4 of the Neighbourhood Plan could be achieved.

9.11 Open Space

- 9.11.1 Core Strategy Policy CS15 seeks to ensure adequate open space is provided to serve the needs of new development. New development should meet the standards in the Open Spaces Strategy and long-term management and investment plans for new facilities will be secured. This policy generally accords with the NPPF paragraph 98 and does not directly prevent the supply of housing. As a result, it is not considered that there is a need to reduce the weight that should be given to the policy.
- 9.11.2 Policy BuS5 of the Neighbourhood Plan designates the Millennium Park, to the north-west of the site as a Local Green Space GS07.

9.11.3 The open spaces officer has calculated the open space requirements for the development in accordance with policy CS15.

- 9.11.4 The above on-site provision would be subject to detailed design at reserved matters stage and can be secured within the S106 agreement, alongside measures for public access, timing of delivery and management and maintenance arrangements.
- 9.11.5 The on-site provision is CIL compliant with the requirements of the Community Infrastructure Levy Regulations 2010 (Reg. 122) in that it would be necessary, related to the development and fair in scale and kind, and the off-site commuted sum will secure provision will be local to the site and is thus also compliant with these Regulations. The Parish Council has sought an indoor sports contribution towards a new multi-purpose building. However there have not been details provided of the composition of this project, nor how the proposed development should contribute (i.e. quantum of the request) or how this has been calculated. Accordingly, it is considered it does not meet the tests within the Community Infrastructure Levy Regulations (Regulation 122).
- 9.11.6 The submitted Illustrative Open Space Plan shows open space on site totalling 2.82ha, including public spaces, a LEAP and SuDS to the north and south, landscape buffers and a central pocket park. There is sufficient space on-site to accommodate the required open space shown in table 2 above, and also the SuDS and landscaping areas such as hedgerows and trees. Some green spaces within the site will also be managed for biodiversity as discussed later in this report.
- 9.11.7 Overall, it is considered that the development would provide good quality open space proportionate to its size and that shortfalls in open space provision could be mitigated against through appropriate contributions, all to be secured within the S106 agreement. Accordingly, the proposal is considered to comply with policy CS15 of the Development Plan.

9.12 Ecology and Biodiversity

9.12.1 Core Strategy Policy CS13 seeks to conserve and enhance the natural environment with regard to biodiversity and ecological habitats. The policy supports development that protects biodiversity and geodiversity and those that enhance, restore or re-create biodiversity. The loss of features of biodiversity and geodiversity will only be supported in exceptional circumstances where the

- benefit of the development clearly outweighs the impact. Where there are impacts, the policy requires mitigation or compensation of equal or greater value, likely to result in a net gain in biodiversity. The recent Biodiversity Planning Guidance (May 2022) guides developers in how to meet policy CS13.
- 9.12.2 Policy BuS1 of the Neighbourhood Plan states that development should not harm the network of ecological features and habitats identified in the policy and new development will be expected to maintain and where possible enhance existing ecological corridors for biodiversity, demonstrating overall net gain. The policy identifies the hedgerows and grassland verges along Melton Road and the corridor of plantation woodland adjacent to the west of the site.
- 9.12.3 The NPPF states that planning decisions should minimise impacts upon and provide net gains for biodiversity. Emerging Local Plan policy EV6 seeks 10% biodiversity net gain and the protection and enhancement of habitats, species and networks. Emerging policy EV7 supports the retention of existing trees and new tree planting. Although the Environment Act 2021 makes provision for 10% biodiversity net gain, the relevant sections of the Act have not yet been brought into force to make it a legal requirement and is not currently required by national policy. Therefore, policy EV6 can be given only limited weight until the emerging policy is further progressed towards adoption.
- 9.12.4 The application is supported by an Ecological Assessment (February 2021). The site comprises improved grassland, boundary hedgerows, scrub and trees. The site falls within the impact risk zone of the Barrow Gravel Pits SSSI (1.6km to the south-west). There are three Local Wildlife Sites within 1km of the site, but due to the distances to the sites and lack of hydrological connections, no impacts on them are anticipated. The boundary hedgerows of the site (north, west and east – which is outside the site) classify as S.41 habitats of principal importance. To the west of the site is a semi-mature broadleaved woodland plantation, with potential as bat foraging habitat. The plantation, hedgerows and tree (TN9) have low/negligible bat roost potential. The Assessment concludes that 60% of the grassland and a section of the northern hedgerow will be lost and that a soft landscaping scheme and ecological enhancement should be incorporated into the development as compensation. The Assessment recommends scrub and tree retention, a sensitive lighting strategy for bats, hedgerow retention and enhancement, species rich grassland buffers along hedgerows and a soft landscaping strategy and ecological enhancement A Construction Environmental Management Plan (CEMP) is recommended to control impacts on retained habitats within and adjacent the site. Site clearance should be undertaken under a Reasonable Avoidance Measures Method Statement to avoid harm to reptiles/amphibians and badgers. Site clearance should be undertaken outside of bird breeding season. The Assessment notes opportunities for habitat enhancements including hedgerow planting, grassland planting, bat/bird boxes, gaps under fences and wetland habitat.
- 9.12.5 The Arboricultural Impact Assessment (March 2021) notes 1 middle-aged oak tree on the site (T1 to the east) and a tree belt to the west, outside the site. The

Assessment recommends a detailed Arboricultural Impact Assessment to support any future reserved matters, to mitigate impacts on existing trees, and new tree planting. Drainage proposals may also impact the trees and will be considered at reserved matters stage.

- 9.12.6 The agent submitted a Biodiversity Impact Assessment which has been reviewed. This shows that the development will result in a loss of grassland habitat and a net loss of 0.65 habitat biodiversity units, and a gain of 0.53 hedgerow units.
- 9.12.7 The Borough Council's Senior Ecologist advises that this baseline assessment is acceptable, but the development would likely result in a net loss of biodiversity. As the proposal is in outline, and the layout is yet to be considered, a Biodiversity Impact Assessment will need to be undertaken at reserved matters stage. Net gain for biodiversity could be ensured by reducing the footprint of built development or providing compensatory habitat on blue land adjacent to the site or in the form of off-site compensation (if necessary) secured and agreed through obligations as part of a S.106 Legal Agreement.
- 9.12.8 It is recommended that a mechanism be included within the Section 106 agreement that requires the reserved matters scheme to be BIA tested using an appropriate metric, to deliver net gain on-site, adjacent to the site, or via an off-site mitigation contribution as a last resort.
- 9.12.9 Natural England advise that the development will not have significant adverse impacts on statutorily protected nature conservation sites. The Borough Council's Senior Ecologist advises that the following are secured by condition: (i)roosting/nesting features and the creation and management of on-site habitat.
 - (ii) retention of trees and hedgerows and their protection during construction,
 - (iii) a sensitive external lighting scheme and the SUDS scheme to be designed for biodiversity if possible.
 - The reserved matters layout will need to show what areas are for recreational use and what will be managed or used solely for biodiversity value.
- 9.12.10Overall, a baseline assessment has been agreed and net gain can be secured via the S106 agreement. Subject to the conditions set out above, and the S106 to secure net gain, the proposal will protect and enhance biodiversity in accordance with policy CS13 of the Core Strategy, policy BuS1 of the Neighbourhood Plan and the NPPF.

9.13 Impact on Residential Amenity

- 9.13.1 Policy CS2 of the Core Strategy and EV/1 of the Local Plan seek to protect the amenity of existing neighbours, particularly the privacy and light enjoyed by adjoining residential uses, and future residents. The Charnwood Design SPD (2020) also provides spacing standards and guidance to ensure an adequate level of amenity is achieved.
- 9.13.2 Emerging Local Plan policy H3 sets out internal space standards that would

- need to be met by the development and would be considered at reserved matters stage.
- 9.13.3 The nearest residential property to the east will be separated from new dwellings by landscaping and the intervening open field. The final layout will be determined at outline stage, at which point the amenity standards within the SPD will be considered.
- 9.13.4 A planning condition is recommended to secure development in accordance with the nationally described space standard, as this policy is at an advanced stage, is in accordance with the NPPF paragraph 130 and has limited objections. This condition has been recently been accepted by the Planning Inspectorate as reasonable and necessary for emerging allocation DS3(HA15) (application P/21/0550/2, appeal decision APP/X2410/W/21/3289048 dated 18/11/22).
- 9.13.5 Therefore, it is considered that, subject to the recommended condition, the proposal could comply with the provisions of policies CS2 and EV/1 along with the guidance set out in the Design and Housing SPD's to protect residential amenity.

9.14 Noise, Air Quality and Contamination

- 9.14.1 Core Strategy Policy CS2 requires new developments to protect the amenity of people who live and work nearby and those who will live in the new development. Core Strategy Policy CS16 states that new development will be supported that protects environmental resources including local air quality.
- 9.14.2 The NPPF states that planning decisions should ensure new development is appropriate for its location, and avoid noise giving rise to significant adverse impact on health and quality of life. Planning decisions should identify opportunities to improve air quality or mitigate impacts, and ensure the site is suitable for its proposed use, taking account of ground conditions.
- 9.14.3 Emerging Local Plan policy DS5 states that new development will be required to protect the amenity of people who live or work nearby and those who live in the new development. Emerging policy EV11 states that the Council will support development that does not lead to a significant impact upon, and deterioration of local air quality resulting an unacceptable impact on human health, local amenity or the natural environment.
- 9.14.4 The application is supported by an Air Quality Screening Report (Wardell Armstrong, March 2021) The site is not located within an area of concern for air quality. Impacts from dust etc during construction can be mitigated via a construction management plan. Although the site will generate traffic onto local roads, the site is not located in an area of concern in relation to poor air quality, so the impact of the development on air quality in the local area is considered to be 'not significant'. There are no other pollution sources need the site, other than Melton Road. The Environmental Health officer raises no concerns regarding air quality/odour.

- 9.14.5 The application is supported by a Noise Assessment Report (Wardell Armstrong, March 2021). The report concludes that the site is affected by road noise from the traffic on Melton Road and that dwellings closest to Melton Road will require some noise mitigation to meet external and internal noise guideline levels. Dwellings closest to Melton Road should have gardens on the screened side of dwellings, furthest away from the road. Facades of dwellings closest to and facing Melton Road will require enhanced glazing and an alternative means of ventilation to ensure that noise guideline levels are met in sensitive rooms whilst maintaining adequate ventilation. The assessment is based upon dwellings being located at least 10m from Melton Road.
- 9.14.6 The Environmental Health officer advises that should planning permission be granted further assessment will be necessary to confirm mitigation measures to ensure internal and external noise guidelines can be achieved and overheating does not occur. A glazing scheme, combined with an alternative means of ventilation to remove the need to open windows, is likely to be required within living room and bedroom areas of dwellings closest to and facing Melton Road. Glazing and ventilation requirements will therefore need to be confirmed, once a detailed design layout is available. Garden areas in properties nearest to Melton Road are also likely to require location on the screened sides of dwellings or provision of 1.8m high acoustic fencing to ensure appropriate external noise levels. Therefore, conditions to secure details of mitigation measures on a plot by plot basis are required.
- 9.14.7 The application is supported by a Ground Assessment Report (Enzygo Ltd, March 2021). The report confirmed the site is considered to present a negligible/low to moderate risk from ground contamination.
- 9.14.8 The Environmental Health officer recommends an intrusive ground investigation is secured by planning condition, requiring remediation where necessary. The Environment Agency raise no comments but suggest an informative regarding historic landfill.
- 9.14.9 Overall, subject to the recommended conditions, the development is considered to comply with Core Strategy policies CS2 and CS16, emerging Local Plan policies DS5 and EV11 and the NPPF.

9.15 Heritage impacts

9.15.1 Section 66 of the Planning (Listed Buildings and Conservation Areas) Act 1990 (as amended) states that in considering whether to grant planning permission for development which affects a listed building or its setting, the local planning authority shall have special regard to the desirability of preserving the building or its setting or any features of special architectural or historic interest which it possesses. Therefore, significant weight must be given to these matters in the assessment of this planning application.

- 9.15.2 Listed Buildings are designated heritage assets, and paragraph 199 of the NPPF states that: when considering the impact of a proposed development on the significance of a designated heritage asset, great weight should be given to the asset's conservation (and the more important the asset, the greater the weight should be). This is irrespective of whether any potential harm amounts to substantial harm, total loss or less than substantial harm to its significance.
- 9.15.3 Policy CS14 of the Core Strategy states that the Council will require development to protect heritage assets and their setting, an emerging policy EV8 states that the Council will support development that protected and enhances heritage assets and prevents harm to their significance and setting.
- 9.15.4 The application is supported by a Heritage Statement. The Statement concludes that the site has potential for archaeological remains and recommend mitigation through a programme of archaeological works. The site is not considered to have any meaningful relationship to the Barrow upon Soar Conservation Area or any of the listed buildings or their setting.
- 9.15.5 The site does not contain or is adjacent to any heritage assets (designated or non-designated) and is separated from them by some distance and intervening development. It is therefore considered that it would not harm them or their settings, subject to a planning condition to secure a written scheme of investigation. It would therefore satisfy the requirements of Policy CS14 of the Core Strategy, emerging Local Plan Policy EV8 and the NPPF.

9.16 Highway Matters

- 9.16.1 Core Strategy Polices CS2 requires new development to provide well defined and legible streets and spaces that area easy to get around for all. Core Strategy Policy CS17 promotes sustainable travel and requires major development to provide walking, cycling and public transport access to key facilities and services, safe and well-lit streets, secure new bus stops/services where development is more than 400m from an existing bus stop. Core Strategy Policy CS18 requires network improvements where they are identified in Transport Assessments. Local Plan Policy TR/18 requires off-street parking to be provided for vehicles and cycles to secure highway safety and minimise harm to visual and local amenities. Adopted standards are provided as a starting point to assess the level of provision. These policies generally accord with the National Planning Policy Framework and do not directly prevent the supply of housing. As a result, it is not considered that there is a need to reduce the weight that should be given to them.
- 9.16.2 Policy BuS13 of the Neighbourhood Plan states that new housing developments of more than ten dwellings will not be supported unless it can be demonstrated that the residual cumulative impact will not make existing traffic conditions worse. Policy BuS15 states new development should retain and where appropriate incorporate linkages to the Public Rights of Way network.
- 9.16.3 Paragraph 110 of the NPPF seeks to promote sustainable travel choices.

Paragraph 111 of the NPPF seeks to ensure new development does not result in an unacceptable impact on highway safety, or a severe residual cumulative impact on the road network.

- 9.16.4 Emerging Local Plan policy CC5 states that Council will support sustainable patterns of development which will minimise the need to travel and seek to support a shift from travel by private car to walking, cycling and public transport. The policy states that we will support major development that secures, where possible, new and enhanced bus services, including new bus stops where development is more than a 400m walk from an existing bus stop. Emerging policy CC6 supports development that provides electric vehicle charging for each new dwelling with a dedicated parking space. Emerging policies INF1 and INF2 seek to secure appropriate infrastructure to mitigate the impacts of development.
- 9.16.5 Public comments have raised concerns regarding the need for highway improvements at pinch points within Barrow (e.g. Grove Lane/South Street), impact of flooding on traffic, need for speed reduction measures at Grove Road, Melton Road and South Street, the need for car parking in the village centre, lack of train services and the distance of the site to services.
- 9.16.6 The application is supported by Transport Assessment (WYG, Issue 2 March 2021), Access Drawing B025468-TTE-OO-XX-SK-D-00001-P03, Travel Plan Issue 1 (WYG, March 2021), Response to LHA comments (Tetra Tech. Rev 2 Sept 2021), Stage 1 Road Safety Audit (Tetra Tech, Sept 2021) Road Safety Audit Designer's Response (Tetra Tech, 28/9/21) and Technical Note Junction 2 mitigation (Tetra Tech).
- 9.16.7 The Highway Authority has advised as follows:;

9.16.8 Site Access

Melton Road is a C classified road, subject to the national speed limit (60 mph) adjacent to the site. The speed limit changes to 30 mph approximately 115m southwest of the proposed site access junction.

9.16.9 The site will be accessed from Melton Road via a new ghost island junction from Melton Road, approximately 120m northeast of the Melton Road / Fishpool Way Roundabout. The layout of the proposed access is shown in drawing number B025468 TTE 00 XX SK D 00001 Rev P03. The site access is comprises a 7.3m wide site access arm with a 2m wide footway on the western side of the road. The Highways Authority is content that the visibility splays of 2.4m x 40m southwest and 2.4m by 215m to the northeast are acceptable. As shown in Appendices A and B of the TA, to accommodate the ghost island right turn lane, Melton Road has been widened into the existing north side verge in the vicinity of the proposed site access. Lanes 3.2m wide will be provided for through traffic, with a 3m wide right turn lane.

9.16.10Highway Safety

Highway safety data has been submitted for 2014-2021. The Highways Authority consider that the proposed development does not raise any concerns with regard to the existing highway safety situation.

9.16.11Junction Capacity and Trip Generation

The applicant has undertaken junction capacity assessments for the following junctions:

- 1. Fishpool Way/Melton Road Roundabout;
- 2. Grove Lane/South Street Priority Junction;
- 3. South Street/Melton Road Priority Junction;
- 4. South Street/High Street/Bridge Street Roundabout; and
- 5. Melton Road/Site Access Priority Junction.

The Transport Assessment included a capacity analysis of the current application and the pending application opposite for 135 dwellings (P/21/0759/2). The Highways Authority requested further information regarding the impact on the Grove Lane junction, and how queueing traffic would re-direct to other junctions.

9.16.12The Highways Authority conclude that modelling results show that all junctions would operate at an acceptable level of capacity in 2026 with both proposed sites in place with the assumed re-assignment of development trips, which the LHA considers to be acceptable in this instance. It is therefore considered that mitigation is not warranted at the Grove Lane/South Street priority junction since it would operate within practical capacity even under the demand from both developments should they be granted planning permission.

9.16.13Off-site implications

The site access drawing, drawing number A113489 27 C P001 Rev P01 shows the 2m footway along Melton Road to Fishpool Way, and an uncontrolled crossing point of Fishpool Way. This can be secured by condition.

9.16.14The Highways Authority request a Construction Traffic Routing Agreement is secured via the S106 agreement and a Construction Traffic Management Plan is secured by condition.

9.16.15 Internal Layout

As the application is in outline, with only access to be determined at this stage, the submitted indicative site layout and matters such as the proposed numbers of parking spaces have not been reviewed or considered by the LHA in preparing this response. However, the TA suggests that the internal road network would be put forward for adoption and accordingly, the LHA advises that the proposals are required to be designed in accordance with the prevailing Leicestershire Highways Design Guide (LHDG) and local parking standards when a future reserved matters application is submitted.

9.16.16 Sustainability

The site is located in excess of 1km from the village centre and associated amenities such as the local primary school, churches and local shops. However, there will be good footway links both to the village centre and to the surrounding area.

- 9.16.17The nearest bus stop serving the site is located on Babington Road, southbound only which is in excess of 500m of the site, with the nearest northbound stop being in excess of 700m from the site and located on Melton Road. These are served by half-hourly services between Leicester and Loughborough. Barrow upon Soar railway station is located on Grove Lane, approximately 900m from the proposed site which operates services to Leicester and Lincoln. Therefore, there are opportunities for sustainable travel, albeit not in close proximity to the site.
- 9.16.18The Highway Authority request Travel Packs (to include 6 month bus passes) and improvements to four bus stops (i.e. 2 stops closest to entrance point at Melton Road and 2 stops closest to entrance point at Brook Lane) In the form of road markings at the following stops at a cost of £1,500 per stop, which can be secured by S106 agreement.

9.16.19Travel Plan

The Highway Authority has reviewed the Travel Plan (TP) which has been submitted with the application. Whilst the TP is generally acceptable in relation to monitoring and the recording of initiatives and events, the use of Modeshift Stars is recommended. An amended TP can be secured by way of a planning condition and an appropriate Travel Plan monitoring fee via a Section 106 agreement.

9.16.20Public Rights of Way

The site does not include footpaths or bridleways but is close to I23/2 to the south and I20/3 within the adjacent woodland to the west. The development proposal will impact on both of these routes.

The Highway Authority are seeking a financial contribution towards drainage and surfacing improvements to Public Bridleway I20 (from the rear of the development to Melton Road) due to the increased use that the bridleway will receive from residents of the development. In addition, they are seeking a tarmacadam surface to Public Footpath I23 (from the rear of the proposed development and the development under construction off Fishpool Way) to create a surfaced link from the development to the amenities of Barrow. These improvements would encourage sustainable travel to and from the site, achieving modal shift targets, and support wellbeing and can be secured within the S106 agreement. A planning condition is suggested to secure that the layout includes a link from within the site, to the adjacent footpath I23/2.

9.16.21In conclusion, it is considered that the impacts of the development on highway safety would not be unacceptable, and when considered cumulatively with other developments, the impacts on the road network would not be severe. Based on the information provided, the development therefore does not

- conflict with paragraph 111 of the NPPF subject to the conditions and planning obligations outlined above.
- 9.16.22The development will not be within 400m of an existing bus stop and no new or enhanced bus service provision is proposed, contrary to Core Strategy policy CS17 and emerging policy CC5, however, bus stop improvements are to be secured. Overall, subject to planning conditions and S106 obligations it is considered that the proposal will meet the other requirements of these policies and policies CS2 and CS18 of the Core Strategy, policy BuS13 and BuS15 of the Neighbourhood Plan and emerging policies CC5, INF1 and INF2. Compliance with policies CS2, TR/18 and emerging policy CC6 can be secured at reserved matters stage.

9.17 Flooding and Drainage

- 9.17.1 Policy CS16 of the Core Strategy directs development to areas of lowest flood risk and supports development which reduces flood risk elsewhere. The policy requires development to manage surface water run off with no net increase in the rate of surface water run off for green field sites. This policy generally accords with the NPPF and does not frustrate the supply of housing. It is therefore not considered there is a need to reduce the weight afforded to this policy.
- 9.17.2 The NPPF requires major developments to incorporate sustainable drainage systems, unless there is clear evidence that this would be inappropriate.
- 9.17.3 Emerging local plan policy CC1 directs development to flood zone 1 and requires major development to be supported by a Flood Risk Assessment. Emerging local plan policy CC2 supports major developments that use sustainable drainage systems in accordance with the drainage hierarchy, to provide multifunctional benefits and to secure their maintenance.
- 9.17.4 Public comments have raised concerns regarding the impact on flooding and foul sewerage capacity.
- 9.17.5 The application is supported by a Flood Risk Assessment (Enzygo, March 2021). The site is in flood zone 1 but there is a residual risk of flooding from the bounding drains, groundwater flooding and from a surface water flow pathway. The site has an ordinary watercourse along the northern boundary and land levels fall from south-east to north-west by a gradient of 1:22. The use of Sustainable Drainage techniques will improve water quality of surface water runoff, thereby offer a betterment to existing conditions. Post-development surface water run-off will be directed to the attenuation basin to discharge to the northern drain and a restricted Q-BAR rate, thereby offering a betterment to existing conditions. The FRA proposes that the residual risk from land drains, surface water flooding and groundwater flooding can be mitigated (FRA paragraph 5.2). Surface water runoff from the proposed development would be attenuated on-site up to and including the 1 in 100-year event, plus 40% climate change. Surface water drainage will be in the form of a detention basin, to outfall to the bounding land drain. Details of other SuDS features and maintenance

- would be considered further at detailed design, when a detailed layout has been produced. An indicative drainage layout is provided.
- 9.17.6 The application is supported by a Foul Drainage Analysis (Utility Law Solutions, March 2021). The proposal is to discharge waste water from the development to the public sewerage network owned and operated by Severn Trent Water.
- 9.17.7 Severn Trent Water request an information note on any planning permission granted regarding their sewers.
- 9.17.8 The Leicestershire Lead Local Flood Authority advise that the indicative surface water drainage strategy is sufficient at this outline stage, subject to planning conditions to secure a surface water drainage scheme, management of surface water during construction and maintenance of the surface water drainage system and infiltration testing.
- 9.17.9 Therefore, it is considered that in principle the proposed development meets the Core Strategy Policy CS16 and emerging Local Plan policies CC1 and CC2 subject to the recommended conditions.

9.18 Sustainable construction and energy efficiency

- 9.18.1 Core Strategy Policy CS16 encourages sustainable design and construction where it does not make the development unviable and requires major development to demonstrate how the need to reduce emissions has influenced the design, layout and energy source used.
- 9.18.2 The Design and Access Statement refers to the use of renewable technologies such as solar panels, a fabric first approach to construction, cycle infrastructure and electric vehicle charging points.
- 9.18.3 The final sustainable design details will be considered at reserved matters stage, where layout and design will be finalised and accordance with policy CS16 can be secured.

9.19 Section 106 Contributions

- 9.19.1 Core Strategy Policies CS3, CS13, CS15, CS17 and CS24 of the Core Strategy requires the delivery of appropriate infrastructure to meet the aspirations of sustainable development either on site or through appropriate contribution towards infrastructure off-site relating to a range of services. Policy BuS12 of the Neighbourhood Plan states that development should be supported by new or improved infrastructure, including school provision, a new community centre, improvements to the health centre and library and sports and recreation provision.
- 9.19.2 As set out within the Community Infrastructure Levy (CIL) Regulations 2010, planning obligations must only be sought where they are necessary to make the development acceptable in planning terms, directly related to the development and fairly related in scale and kind to the

development. Consultation regarding the application resulted in the following requests to meet infrastructure deficits created by the development:

Education Early years childcare contribution required as the development is over 100 dwellings (11.05 early years increase from this development) of £98,422.00 to improve, remodel or enhance existing facilities at a new primary school, Barrow Hall Orchards Primary School or any other schools/early learning provision within the locality of the development In accordance with the Education Strategy for Barrow: **Primary provision**: Proportionate contribution to 1FE primary school to serve Barrow of 21.74% of total costs, reflecting the share of overall growth (stated in the Delivery Strategy as £1,944,564.63, (to be reviewed and confirmed at the time of signing); Necessary transition funding to provide temp accommodation and/or school transport costs in advance of new school To transport up to 39 pupils to various primary sites will require 3x minibuses at a cost of around £480 per day, £2,400 per week. For 39 weeks per year that school is open will cost = up to £93,600 per year Secondary provision – Contribution of £388,087.96 to accommodate 22 pupils generated by the improving, remodelling, development by enhancing existing facilities at Humphrey Perkins School or any other school within the locality of the development. Post 16 requirement of £82,912.83 to accommodate capacity issues created by the development (5 places) are required from this development by improving, remodelling or enhancing existing facilities at Rawlins Academy or any other school within the locality. **Special Schools** - Confirms that all Special Schools in Leicestershire are full, and have a deficit of available spaces, and are forecast to remain so. This development would generate a claim for 0.47 primary and 0.52 secondary SEN pupils. The closest school to this development is the Ashmount School in Loughborough which would have a deficit of 10 places. A contribution of £73,382.96 is requested to accommodate these pupils to provide additional capacity at the nearest school. Libraries £3,930 contribution towards the enhancement of Barrow Library.

- 9.19.3 The County Council Local Education Authority advises that the existing school in Barrow (Barrow Hall Orchard C of E Primary School) is at maximum size, and there are no other schools within 2 miles of the development that can be expanded. Therefore, a new primary school is required.
- 9.19.4 As discussed earlier in this report, the proposal will provide a financial contribution to the new one form entry primary school planned for Barrow upon Soar, as part of the emerging Local Plan. The agreed Barrow Education Delivery Strategy (Appendix A) sets out that the developer of this site will pay the primary education contribution in full prior to commencement of development. The school will be located on site HA48 (land at Willow Road) and the 1.1 hectare site for the school will be transferred to the County Council prior to commencement of any superstructures on HA48 (land at Willow Road).). The total cost of the school is therefore £10,814,771. The agreed Barrow Education Delivery Strategy notes that the construction cost of the school is an estimate and that a final CIL compliant build cost will be determined prior to the signing of the first S106 agreement for the development sites at Barrow, allowing for any variation that occurs in the time that passes. It will contain indexation clauses to prevent it falling behind rising costs.
- 9.19.5 Based upon the £10.81 million figure, for this 130 dwelling proposal the contribution will be £1,944,564.63 (21.74% of the total capital). The agreed Barrow Education Delivery Strategy (Appendix A) sets out that applicant has agreed that the S106 for this proposal will include a restriction that the development will not commence until the County Council confirms that the school site at Willow Road has been transferred to them.
- 9.19.6 Dependent upon the timing of the delivery of the new school, financial contributions may also be necessary to cover the cost of transporting the 39 pupils generated by the development to the nearest primary school for a temporary period whilst the primary school is under construction (current calculations provided by the County Council show this cost to be 3 minibuses at £480 per day/£2,400 a week for 39 weeks per year). The details of the transitional funding arrangements will be detailed within the S106 agreement. Transitional arrangements are considered reasonable and necessary to ensure that primary aged children have appropriate school provision.
- 9.19.7 There are several requests made by the Parish Council. The requests for highways, bus stop and footpath improvements, school contributions, open space, healthcare and library contributions are covered by the requests of other consultees. The further requests from the Parish Council do not include

evidence to demonstrate that they are compliant with the Community Infrastructure Levy Regulations. The requests highlight existing issues for which the development is not responsible and thus do not meet the three tests of necessary, directly related and fairly and reasonably related in scale and kind to the development. The request for a contribution to a new community centre is supported by policy BuS12 of the Neighbourhood Plan (and BuS11), but no evidence has been provided to support this request, such as a chosen site for the centre and a designed and costed scheme, to enable a proportionate contribution from this development to be calculated. Therefore, a contribution cannot be justified and sought.

- 9.19.8 The indoor sport contribution is not considered to be CIL compliant, as set out in the open space section of the report.
- 9.19.9 These contributions (with the exception of indoor sport and some Parish Council requests) are considered to be compliant with the Community Infrastructure Levy Regulations and would allow the necessary infrastructure to meet Core Strategy policy CS24.

9.20 Planning Balance and Conclusion

- 9.20.1 As there is currently an insufficient supply of deliverable housing sites (3.04 years), this application is to be determined on the basis of para 11d and the presumption in favour of sustainable development in the NPPF. This means that there must be adverse impacts which would significantly and demonstrably outweigh the benefits for planning permission to be refused.
- 9.20.2 The development is situated adjacent to Barrow upon Soar, which Core Strategy Policy CS1 defines as an 'service centre' and a sustainable location for residential development. This site is not within the defined settlement boundary but is close to the existing settlement and the defined boundary.
- 9.20.3 The development would provide up to 130 new dwellings, of which 30% would be affordable, at a time when there is an acute need for these and that would be a significant benefit of the scheme. These would be provided adjacent to a settlement in the Borough where there is a good level of local facilities and a bus service to Loughborough and Leicester and which has been identified as a 'service centre' suitable for residential development. The site offers the potential for quality design and an acceptable mix of housing. These matters should be afforded significant weight.
- 9.20.4 The site is also allocated in the emerging Local Plan as site reference DS3 (HA45) which is considered to provide further weight, albeit limited to moderate, in favour of the proposal.
- 9.20.5 There are no technical constraints relating to highways or flooding that cannot be mitigated. Biodiversity impact and landscaping can be secured by way of planning condition, reserved matters and S106 legal agreement. There would be no harm to heritage assets or archaeology, subject to condition.

- 9.20.6 Weighed against this is the conflict with Development Plan policies relating to the Countryside. The proposed development would be contrary to the relevant provisions of saved Core Strategy Policy CS1 and BuS16 of the Neighbourhood Plan based on its location outside the settlement boundary. Core Strategy Policy CS11 and Local Plan policy CT/2 seek to protect the countryside with development only accepted in limited circumstances, and with Core Strategy Policy C17 and emerging Local Plan Policy CC5 owing to the distance from bus stops..
- 9.20.7 The Committee may find recent appeal decisions in the Borough instructive in their determination of weight within the 'planning balance'. A recent appeal decision at land east of Cossington Road, Sileby (P/21/0491/2) was upheld on the basis of housing supply despite its location within an Area of Separation (a stronger constraint than present in this applications) and appeals at Iveshead Rd, Shepshed, Maplewell Rd, Woodhouse and at Main Street, Woodthorpe have all been upheld on the basis of housing supply benefits outweighing landscape harm and conflict with planning policies, including Neighbourhood Plan policies.
- 9.20.8 In conclusion, there are no technical reasons that would prevent approval, such as highways or drainage, but it is recognised that the proposals would fail to protect the countryside and is therefore accounted for as harm. This is to be weighed in the planning balance of NPPF paragraph 11 d) whereby any adverse impact would need to significantly and demonstrably outweigh the benefits and, considering that the Council can only demonstrate 3.04 years supply, the benefit of providing housing, including affordable housing is also significant. Furthermore, as this is an outline application with potential for conditions and reserved matters to be agreed, there is reasonable scope that they be mitigated to a certain extent, reducing their harmfulness, and appeal decisions on this matter give an indication of the weight to be assigned to such harm versus the benefit of providing much needed housing.
- 9.20.9 Given that there is scope to impose planning conditions to mitigate harm to landscape and visual impacts, it is considered that, overall, the adverse impacts of granting permission would not significantly and demonstrably outweigh the benefits.
- 9.20.10The application is therefore recommended to be supported subject to appropriate planning conditions being attached and contributions being secured to support local infrastructure as part of a S106 Legal Agreement, as set out below.

10. RECOMMENDATION A:

10.1 That authority is given to the Head of Planning and Growth and the Head of Governance and Human Resources to enter into an agreement under section 106 of the Town and Country Planning Act 1990 to secure improvements, on terms to be finalised by the parties, as set out below:

10.2 RECOMMENDATION B:

That subject to the completion of the S106 agreement in recommendation A above, grant Conditionally subject to the imposition of the following draft conditions and reasons and that the Head of Planning and Growth, in consultation with the Chair of the Plans Committee for amendments to the conditions and reasons, be given delegated authority to determine the final detail of planning conditions. Planning conditions:

Application for approval of all the reserved matters shall be made to the Local Planning Authority before the expiration of five years from the date of this permission and the development hereby permitted shall be begun either before the expiration of five years from the date of this permission or before the expiration of two years from the date of approval of the last of the reserved matters to be approved whichever is the later.

REASON: To comply with the provisions of Section 92 of the Town and Country Planning Act 1990, as amended by Section 51 of the Planning and Compulsory Purchase Act 2004, and Article 5(1) of the Town and Country Planning (General Development Procedure) Order 2015 (as amended).

Details of the layout, scale, appearance and landscaping (hereafter referred to as 'the reserved matters') shall be submitted to and approved in writing by the Local Planning Authority before any development takes place and the development shall be carried out as approved.

REASON: To comply with the provisions of Section 92 of the Town and Country Planning Act 1990, as amended by Section 51 of the Planning and Compulsory Purchase Act 2004, and Article 6 of the Town and Country Planning (Development Management Procedure) (England) Order 2015 (as amended).

- The development hereby permitted shall be carried out in accordance with the following plans and documents:

 - Proposed Site Access Layout B025468-TTE-00-XX-SK-D-00001 Rev P03

Both received 1/4/21 by the Local Planning Authority.

REASON: For the avoidance of doubt.

The details submitted pursuant to condition 2 above shall include full details of existing and proposed ground levels and finished floor levels of all buildings relative to the proposed ground levels. The development shall thereafter be carried out in accordance with the approved details.

REASON: To ensure the development is in character with its landscape and surroundings and to ensure amenity of new residents is protected in accordance with policies CS2 and CS11 of the Core Strategy and policy EV/1 of the Local Plan.

- The layout and landscaping submitted details pursuant to condition 2 shall include:
 - Save for hedgerow removal required to enable the access road and its visibility splays hereby approved, or to provide a potential connection to Public Right of Way I23/2, the retention of all existing hedgerows and trees;
 - Medium stature trees to line the main access road;
 - Tree planting to the south and eastern site boundaries;
 - Planting in the open spaces to include large and very high canopy trees;
 - Public open space within the most elevated areas of the site;
 - A footpath connection from within the site to the public footpath 123/2 to the south.

REASON: To minimise the landscape and visual impact of the development in accordance with the Landscape and Visual Assessment (TEP, March 2021) to integrate and connect the development into the landscape and to the village and to comply with policies CS2 and CS11 of the Charnwood Local Plan 2011-2028 Core Strategy (2015).and NPPF

- The details submitted pursuant to condition 2 above shall include the following minimum amounts and typologies of open space:-
 - Multi-function green space (minimum 0.45ha parks and 0.1ha amenity green space)
 - Natural open space (minimum 0.6ha)
 - LEAP facility

REASON: To ensure that the open space needs of future residents are met at a level that complies with Policy CS15 of the Charnwood Local Plan 2011-2028 Core Strategy (2015).

- 7 The landscaping details submitted pursuant to condition 2 above shall include:
 - i) the treatment proposed for all ground surfaces, including hard surfaced areas;
 - ii) planting schedules across the site, noting the species, sizes, numbers and densities of plants and trees; including tree planting within the planting belt to the east of the site;
 - iii) finished levels or contours within any landscaped areas;
 - iv) any structures to be erected or constructed within any landscaped areas including play equipment, street furniture and means of enclosure.
 - v) functional services above and below ground within landscaped areas; and
 - vi) all existing trees, hedges and other landscape features, indicating clearly any to be removed.

 - viii) position and type of bins to be provided.

REASON: To make sure that a satisfactory landscaping scheme for the development is provided so that it integrates into the landscape and surrounding area and complies with policies CS2 and CS11 of the Charnwood Local Plan 2011-2028 Core Strategy (2015) and saved policy EV/1 of the Borough of Charnwood Local Plan.

The details to be submitted pursuant to condition 2 shall include a housing mix for market and affordable homes in reflect up to date evidence of housing need in the Borough.

REASON: To secure the development provides an appropriate mix of homes having regard to the identified housing needs of the area in accordance with policy CS3 of the Core Strategy and the NPPF.

9 The details to be submitted pursuant to condition 2 shall show all units in compliance with the Nationally Described Space Standards.

REASON: To secure a high standard of amenity for future residents in accordance with emerging Policy H3 of the Charnwood Local Plan 2021-37 and paragraph 130 of the NPPF.

The details to be submitted pursuant to condition 2 shall include that 10% of new market homes will meet the Building Regulations Part M4(2) standard for being accessible and adaptable. The affordable homes on the site shall meet the M4(2) and/or M4(3) standards for being suitable for wheelchair users, unless otherwise agreed by the Council following submission of an assessment of viability and/or site-specific constraints.

REASON: To meet the needs to the ageing population and people with disabilities and to secure a high standard of amenity for future residents in accordance with emerging Policy H2 of the Charnwood Local Plan 2021-37 and paragraph 130 of the NPPF.

Prior to commencement of the development hereby approved, a Landscape and Ecology Management Plan (LEMP) shall be submitted to and approved in writing by the Local Planning Authority. The LEMP shall include a landscape management plan, including long term design objectives, management responsibilities and maintenance schedules for all public open spaces, ecological mitigation areas and surface water drainage system. Thereafter, the LEMP shall be carried out in accordance with the approved details.

REASON: To ensure that public areas are maintained at good quality and that drainage systems retain full function and to protect habitats of importance to biodiversity conservation on the site from any loss or damage in accordance with Policies CS2, CS11, CS13, CS15 and CS16 of the Charnwood Local Plan 2011-2028 Core Strategy (2015) and the NPPF and saved policy EV/1 of the Borough of Charnwood Local Plan.

No development shall take place unless the Local Planning Authority has given its written approval that it is satisfied that the risk from contamination has been adequately characterised as required by this condition.

REASON: To ensure that any ground and water contamination is adequately addressed to ensure the safety of the development, the environment and to ensure the site is suitable for the proposed use, to comply with policy CS2 of the Core Strategy and the NPPF.

17 If contamination is found by undertaking the work carried out under condition 18, prior to the commencement of the development hereby permitted, a scheme of remediation and/or monitoring to ensure the site is suitable for its proposed use shall be prepared by a competent person

and in accordance with DEFRA and the Environment Agency's 'Model Procedures for the Management of Land Contamination, CLR 11' and submitted to and approved in writing by the Local Planning Authority. REASON: To ensure that any ground and water contamination is identified and adequately addressed to ensure the safety of the development, the environment and to ensure the site is suitable for the proposed use, to comply with policy CS2 of the Core Strategy and the NPPF.

No part of the development hereby permitted shall be first occupied until a scheme in general accordance with WYG drawing numbers B025468 TTE 00 XX SK D 00001 Rev P03 has been submitted to, approved in writing by the Local Planning Authority and thereafter implemented, prior to first occupation, in accordance with the approved details.

REASON: To mitigate the impact of the development, in the general interests of highway safety and in accordance with the National Planning Policy Framework (2021).

No development shall commence on the site until such time as a construction traffic management plan, including as a minimum details of wheel cleansing facilities, vehicle parking facilities, and a timetable for their provision, has been submitted to and approved in writing by the Local Planning Authority. The construction of the development shall thereafter be carried out in accordance with the approved details and timetable.

REASON: To reduce the possibility of deleterious material (mud, stones etc.) being deposited in the highway and becoming a hazard for road users, to ensure that construction traffic does not use unsatisfactory roads and lead to on-street parking problems in the area.

No part of the development hereby permitted shall be first occupied until an amended Travel Plan which sets out actions and measures with quantifiable outputs and outcome targets has been submitted to and agreed in writing by the Local Planning Authority. Thereafter the agreed Travel Plan shall be implemented in accordance with the approved details.

REASON: To reduce the need to travel by single occupancy vehicle and to promote the use of sustainable modes of transport in accordance with the National Planning Policy Framework (2021).

No development shall take place until a scheme for the treatment of the Public Right(s) of Way has been submitted to and approved in writing by the Local Planning Authority. Such a scheme shall include provision for management during construction, surfacing, width, structures, signing and landscaping, together with a timetable for its implementation. Thereafter, the development shall be carried out in accordance with the agreed scheme and timetable.

REASON: In the interests of amenity, safety and security of users of the Public Right of Way in accordance with the National Planning Policy Framework (2021).

Prior to construction, any changes to the existing boundary treatment currently separating the application site from the Public Right of Way, must be approved by the Local Planning Authority in accordance with the principles set out in the Leicestershire County Council's Guidance Notes for Developers.

REASON: in the interests of protecting and enhancing Public Rights of Way and access in accordance with Paragraph 98 of the National Planning Policy Framework (2021).

No trees or shrubs should be planted within 1 metre of the edge of the Public Right of Way. Any trees or shrubs planted alongside a Public Right of Way should be of a non-invasive species.

REASON: to prevent overgrowth in the interests of protecting and enhancing Public Rights of Way and access in accordance with Paragraph 98 of the National Planning Policy Framework (2021).

No development approved by this planning permission shall take place until such time as a surface water drainage scheme has been submitted to, and approved in writing by the Local Planning Authority. Prior to the first occupation of each dwelling hereby approved, the drainage scheme

to serve that dwelling shall be constructed and completed in accordance with the approved plans

REASON: To prevent flooding by ensuring the satisfactory storage and disposal of surface water from the site and in accordance with biodiversity interests in accordance with policies CS2, CS13 and CS16 of the Charnwood Local Plan 2011-2028 Core Strategy (2015) and the National Planning Policy Framework (2021).

No development approved by this planning permission shall take place until such time as details in relation to the management of surface water on site during construction of the development has been submitted to, and approved in writing by the Local Planning Authority. The approved details shall be adhered to and implemented throughout the construction period, unless otherwise agreed in writing by the Local Planning Authority.

REASON: To prevent an increase in flood risk, maintain the existing surface water runoff quality, and to prevent damage to the final surface water management systems though the entire development construction phase in accordance with policies CS2 and CS16 of the Charnwood Local Plan 2011-2028 Core Strategy (2015) and the National Planning Policy Framework (2021).

No occupation of the development approved by this planning permission shall take place until such time as details in relation to the long-term maintenance of the surface water drainage system within the development have been submitted to and approved in writing by the Local Planning Authority. The surface water drainage system scheme shall be thereafter managed and maintained in accordance with the approved details.

REASON: To establish a suitable maintenance regime that may be monitored over time; that will ensure the long-term performance, both in terms of flood risk and water quality, of the surface water drainage system (including sustainable drainage systems) within the proposed development in accordance with policies CS2 and CS16 of the Charnwood Local Plan 2011-2028 Core Strategy (2015) and the National Planning Policy Framework (2021).

No development approved by this planning permission shall take place until such time as infiltration testing has been carried out (or suitable evidence to preclude testing) to confirm or otherwise, the suitability of the site for the use of infiltration as a drainage element, has been submitted to and approved in writing by the Local Planning Authority.

REASON: To demonstrate that the site is suitable (or otherwise) for the use of infiltration techniques as part of the drainage strategy in accordance with policies CS2 and CS16 of the Charnwood Local Plan
