

Quarterly Enforcement Report (Q4) 2023/24

1 Overview

- 1.1 The Planning Officers Society (POSe) independent review of the Planning Service undertaken in April 2023 produced the following recommendations for the Planning Enforcement Team:
 - a. The procedure of referring both recommendations for enforcement notices and decisions not to pursue formal enforcement action to ward members is discontinued; and
 - Officers circulate a quarterly report on enforcement matters to the Plans Committee
- 1.2 Following these recommendations, a revised Enforcement Plan and scheme of delegation was approved by Cabinet on 12 October 2023 and the Constitution changes by Council on 6 November 2023.
- 1.3 The changes to the Enforcement Plan and scheme of delegation took effect on 1 December 2023. Therefore, from this date the procedure for referring both recommendations for enforcement notices and decisions not to pursue formal enforcement action to ward members was discontinued.
- 1.4 This is therefore the first quarterly report since the changes have been implemented.
- 1.5 The tables included in sections 2 and 3 detail the sites where action has been taken and the cases where it has been considered not expedient to take any further action during Q4 2023/24. In taking formal action the property details are included on the Council's Enforcement Register and therefore the site details are made public. In respect of the cases where it has been considered not expedient to take any further action the site addresses have been anonymised as this is not public information but should a Councillor wish for any further information on the matter then they should contact the Team Leader for Enforcement, Sarah Hallam and these details can be confidentially provided.

Further clarity on the cases that achieved a harm score of 5 but when further assessment made it was considered in the public interest (not expedient) to pursue the matter any further.

- 5* The unauthorised display of an advertisement automatically achieves a harm score of 5 as it is a criminal offence to erect an unauthorised advertisement. This case identified a technical breach where two 'for sale' boards were displayed at the property. The position of the boards within the curtilage of the property was considered acceptable and did not negatively impact the street scene or cause detriment to amenity of neighbouring residents.
- 5** Works to protected trees automatically achieves a harm score of 5 but in this case, action could only be taken if wilful damage to the trees health could be identified. There was not sufficient evidence to indicate that there was wilful damage and therefore it was not considered in the public interest (not expedient) to pursue the matter further.
- 5*** In this case a harm score of 5 was given. The matter was however considered by the County Council Highways Officer and they have confirmed that the barrier does not cause any highway safety issues therefore it was not considered in the public interest (not expedient) to pursue the matter further.
