CHANGES TO MEMBERSHIP OF THE CABINET

Purpose of Decision

To make changes to the membership of the Cabinet following the resignation on 21st March 2024 of Councillor Louise Jones who was a Member of the Cabinet.

Decision

That the following Cabinet appointments be made with immediate effect, noting that the Leader of the Council will take on Councillor Louise Jones' portfolio temporarily.

<u>Reason</u>

Under the Leader and Cabinet model, Council appoints the Leader, who then chairs and appoints members of the Cabinet (a total of 10 members of Cabinet being the legal maximum, 3 being the minimum) and allocates Cabinet responsibilities.

Background

At the Council meeting on 22nd May 2023, Council resolved that Councillor Miah be appointed Leader of the Council for Council term 2023/24 to 2026/27 (Council minute 7 2023/24 refers). The Local Government Act 2000 and the Council's Constitution provide for the Leader to make appointments to the Cabinet and allocate Executive functions.

Financial Implications

The special responsibility allowances associated with Cabinet appointments will be funded from the existing councillors' allowances budget.
