#### APPOINTMENT OF CO-OPTED INDEPENDENT PERSON-AUDIT COMMITTEE

### Purpose of Report

To enable the Council to make an appointment of a co-opted Independent member of the Audit Committee.

#### Recommendations

That Lynne Alderson be appointed as a non-voting co-opted Independent Member of the Audit Committee until 21 April 2028 or until she ceases to be a co-opted Independent member, whichever is the sooner.

#### Reasons

To appoint a second co-opted Independent member to the Council's audit committee.

## Policy Justification and Previous Decisions

Best practice advice from CIPFA recommends that each local authority audit committee should include at least two co-opted independent members to provide appropriate technical expertise. The Audit Committee currently only includes one independent co-opted member, and therefore recruitment of a second is required to ensure compliance with with best practice.

#### Implementation Timetable including Future Decisions

It is recommended that the appointment be confirmed with immediate effect, for a period of four years.
